WHAT IS THE GYMS ACT

It's a \$30 billion fund to provide grants to the health and fitness industry.

Who is eligible?

- Eligible entities include fitness facilities providing instruction in a program of physical exercise and which offer space for the maintenance and development of physical fitness.
- Eligible entities with equity or right to profit distributions of not less than 50 percent, and which have the contractual authority to control any business, are considered to be affiliated with that business.

The following are <u>not</u> eligible entities:

- Facilities for golf, hunting, sailing, or riding;
- Facilities which are part of a State or local government entity;
- Facilities for which the health and fitness components are incidental.

HOW DOES THE GYMS ACT WORK?

Initial Grants

Amounts are capped at 45% of the facility's 2019 revenue, or \$20 million, whichever is less.

Supplemental Grants

Health and fitness businesses considered severely impacted, with **revenues of 33% or less** in the most recent quarter as compared to 2019, would be eligible for a supplemental grant, of up to 25% of their initial grant.

WHAT DOES IT COVER?

Some of the eligible expenses the grant would cover include:

- a) payroll costs,
- b) rent or mortgage payments, including interest,
- c) utilities,
- d) interest on debt accrued before February 15, 2020,
- e) taxes,
- f) costs required under any State, local, or Federal law or guideline related to social distancing,







Are you in danger of going out of business due to the economic hardships triggered by the COVID-19 pandemic?







Expected membership and revenue recovery timeframe
