# GRADE "A" EQUIVALENCY DETERMINATIONS

- > Canada
  - Last U.S. on-site visits to Canada were conducted in Quebec and Ontario in October 2010
  - Canada performed an on-site evaluation of Grade "A" Milk Safety Program's Laboratory Program in Oregon in July 2011
  - ➤ U.S. visit to farms in Alberta and several face-to-face visits scheduled from October to December of 2011 postponed due to budgetary issues and have not been rescheduled





# GRADE "A" EQUIVALENCY DETERMINATIONS

- > New Zealand
  - ➤ In November 2010, 4 U.S. teams visited 12 plants, 22 farms and 4 laboratories in New Zealand
  - ➤ Main emphasis was to accompany a Recognized Verifier or an Assessor from a Recognized Agency while they were conducting an audit of the plant or farm Risk Management Program
  - ➤ Possible additional visit to New Zealand during 2013 depending on personnel and budgetary resources





# GRADE "A" EQUIVALENCY DETERMINATIONS

#### > EU

- Individual member state equivalency determination issue still has not been addressed by the EU
- The EC still has not identified a technical team to work with the U.S. technical team
- >FDA has informed the EU that we do not have the personnel to conduct this equivalency determination at this time and will not be able to do this until either Canada or New Zealand has been resolved





# EU AUDIT OF U.S. DAIRY PROGRAM

- In June 2012, a team from the EU visited a plant, a dairy farm and a laboratory in Wisconsin; and two plants and a dairy farm in California
- Preliminary results expressed at the exit interview with FDA and USDA were very positive





# RAW MILK FIELD SAMPLING ASSIGNMENT FOR EU

- 153 of 320 samples have been collected to date. Remaining samples will be collected in November 2012 and February 2013.
- Samples are being collected by permitted industry samplers. All samples are being collected as investigational samples (INV).
- Samples are being tested utilizing three (3) separate FDA laboratories (mycotoxins, chemicals and metals).
- Results obtained will be used to address observations from the 2010 EU audit of the entire U.S. dairy program (FDA, State and USDA).

# CVM RAW MILK SAMPLING ASSIGNMENT

- Issued February 2012 for completion in FY 2012; extended into FY 2013 (Oct Nov 2012)
- 1800 samples from dairy farms (900 targeted and 900 random)
- To date, approximately 93% of total samples have been received at the lab
- To date, approximately 88% of total samples have been analyzed





# ENVIRONMENTAL SAMPLING FOR LISTERIA AT SOFT CHEESE FIRMS

- Originally issued in April 2010, received several extensions, final sampling completed mid-2011, results summarized late 2011
- Firms in 27 States were inspected/sampled
- Approximately 20% occurrence of *Listeria* on all the cheese firms inspected
- Approximately 20% occurrence of Listeria on the artisanal cheese firms inspected



# ENVIRONMENTAL SAMPLING FOR LISTERIA AT SOFT CHEESE FIRMS

#### Environmental Sampling: Location

High Risk

Low Risk Zone 1 – Product contact surfaces: conveyors, tables, racks, vats, tanks, pumps, slicers, packaging machines, etc.

Zone 2 — Non-product contact surfaces in close proximity to product: equipment exterior, refrigeration units, floors, etc.

Zone 3 — Telephones, forklifts, walls, drains

Zone 4 – Locker rooms, cafeteria, hallways





# ENVIRONMENTAL SAMPLING FOR LISTERIA AT SOFT CHEESE FIRMS

- Zone 1 Approximately 3% positive samples
- Zone 2 Approximately 6% positive samples
- Zone 3 Approximately 3% positive samples
- Zone 4 No positives
- Finished product samples taken at 8 artisanal cheese firms were tested for *E. coli*, all samples were negative





# ENVIRONMENTAL SAMPLING FOR SALMONELLA AT DRIED MILK FIRMS

- 11 firms inspected in FY 2012
- Approximately 80% of the firms had at least 1 (one) environmental positive
- Approximately 4% of the swabs were positive
- Zone 1 No positives
- Zone 2 Approximately 2% positive samples
- Zone 3 Approximately 3% positive samples
- Zone 4 No positives





# DRUGRESIDUE RISK ASSESSMENT

- Drug Residues in Milk Assessment (Proposal 243 from the 2005 NCIMS)
  - NCIMS Drug Residue Committee requested an FDA Risk Analysis
  - > 25 member team with CFSAN and CVM representatives
  - Drug Risk Assessment Model consists of four modules (On-farm, Processing, Consumer Exposure, and Hazard Characterization)
- Work groups meet monthly



# DRUGRESIDUE RISK ASSESSMENT

- Risk Assessment will evaluate:
  - Likelihood and magnitude of drug use in cattle and drug presence in raw milk
  - Likelihood and magnitude of drug survival in milk and milk products after processing
  - Magnitude of human exposure to a drug via consumption of milk and milk products
  - Consequence of human exposure (acute or chronic)
- Final Result A risk estimation score for a drug based on likelihood and severity of potential health effects





## NATIONAL MILK DRUG RESIDUE DATA BASE

- Milk samples with animal drug residues slightly lower in FY 2011
  - 0.028% or 1,079 of the 3,787,251 milk samples analyzed tested positive for a drug residue.
  - A total of 3,796,684 tests were reported on the samples for 8 different families of individual drugs.
  - 26 testing methods were used to analyze the samples for residues.


