#### **Exhibitor Packet**

### Cancellation at any time will result in a \$200.00 non-refundable fee.

- $\rightarrow$  No exhibitor may assign, sublet, or share the space allotted.
- $\rightarrow$  All representative names must be submitted before Feb. 15, 2025.
- → Set up is from 8:00 am to 5:00 pm on Tuesday, Feb 25. There are no exceptions to this rule. Staff will not be on hand after 5:00 pm to assist and doors will be locked.
- $\rightarrow$  Load and unload in marked areas only.
- → All exhibit materials, equipment, signs, etc. must be contained in the space provided (10x6) with an 8-foot height limit. An additional booth can be purchased if needed.
- → Tear down shall not occur before 1:30 on Thursday, Feb 27.
- → Exhibitors are responsible for staffing the booth at all times.
- → DRWA is not responsible for lost, stolen, or damaged exhibit goods or materials.
- → The Delaware State Fairgrounds is not responsible for lost, stolen, or damaged exhibit goods or materials
- → Do not attach, suspend, or add weight to any part of the booth framework.
- → Do not deface any property not belonging to you including Conference promotional materials.
- → There shall be no obstructions, tripping hazards, etc. in aisleways.
- → Games must be contained to a reasonable space in your exhibit area.

- → Adjacent booth spaces must be visible to all attendees at all times, do not block visibility nor entry to adjacent spaces.
- → No alcohol or illegal substances can be distributed.
- → Be courteous to other exhibitors should you have noisemaking equipment or electronics.
- → Smoking and vaping are allowed outside only and in designated areas.
