Payment Plan Options

**Step 1. Visit apacnow.org:** Navigate to [apacnow.org/invest](https://apacnow.org/invest), and use the single sign-on functionality to log in to your FAA or local affiliate member profile.

**Step 2. Invest:** Identify the amount you would like to invest and change the dollar amount in the suggested donation box.

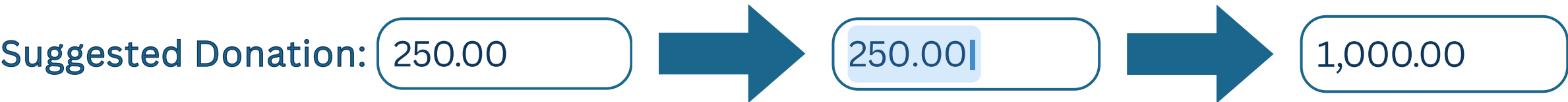
