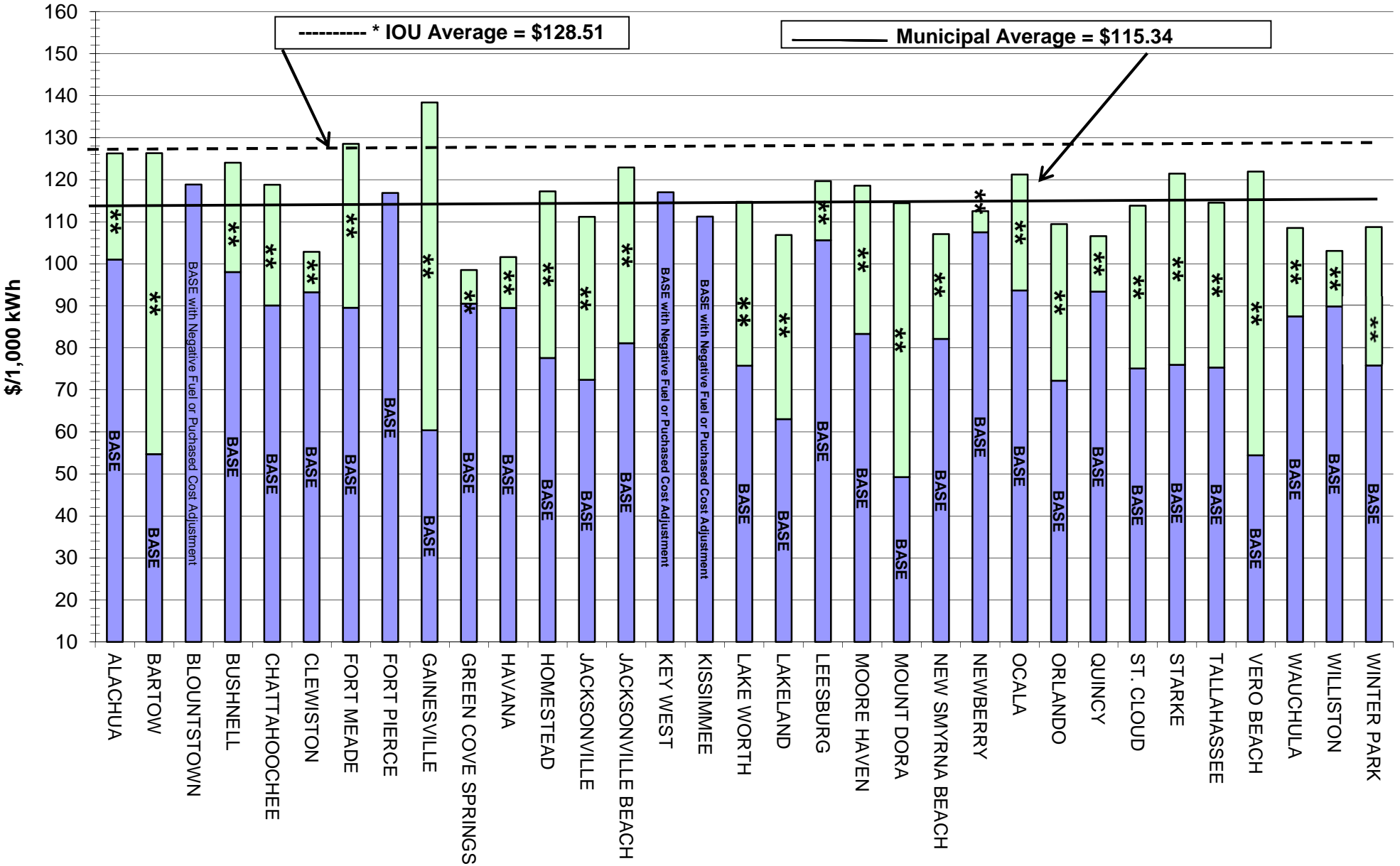


Residential Bill Comparison, October 2015

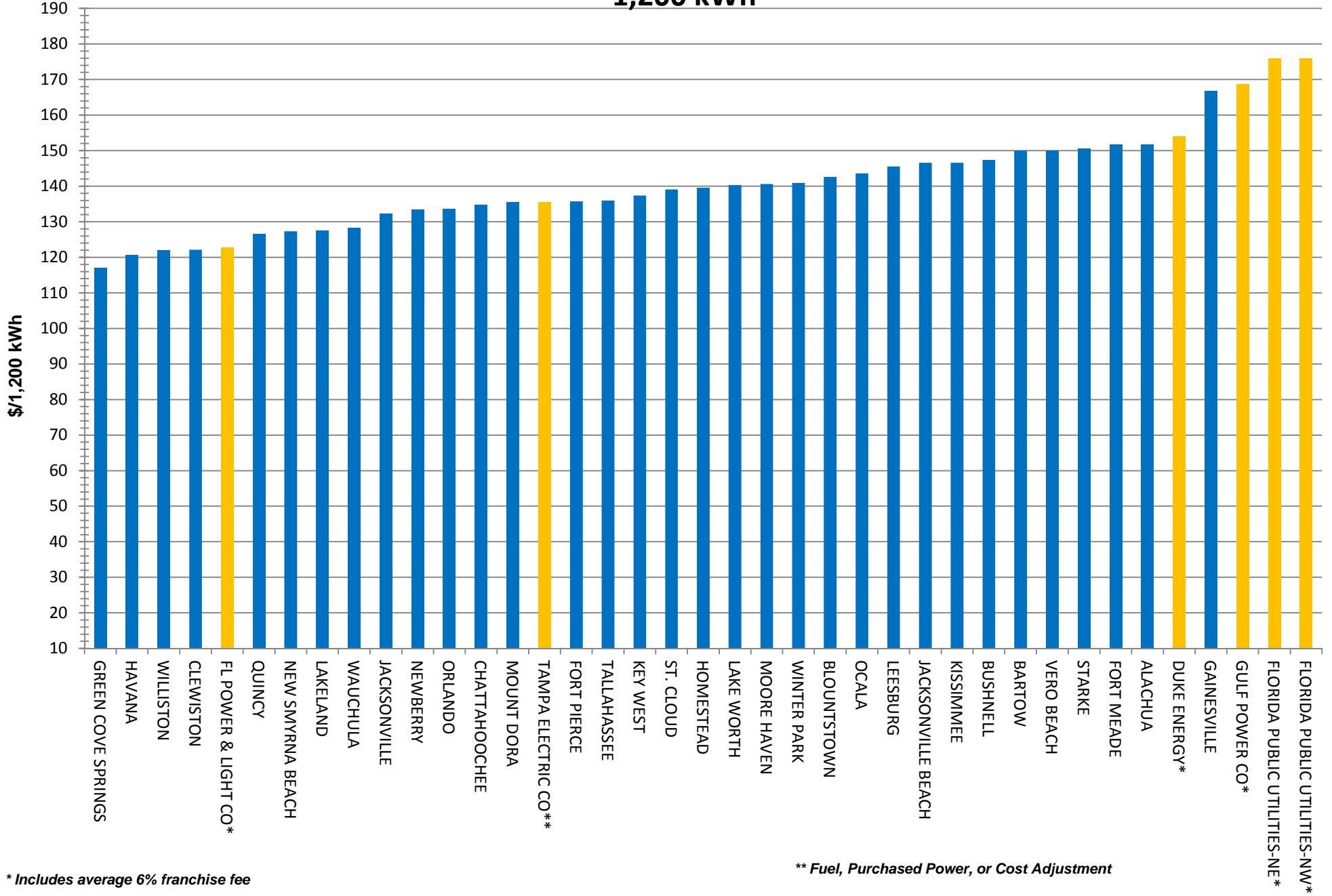
