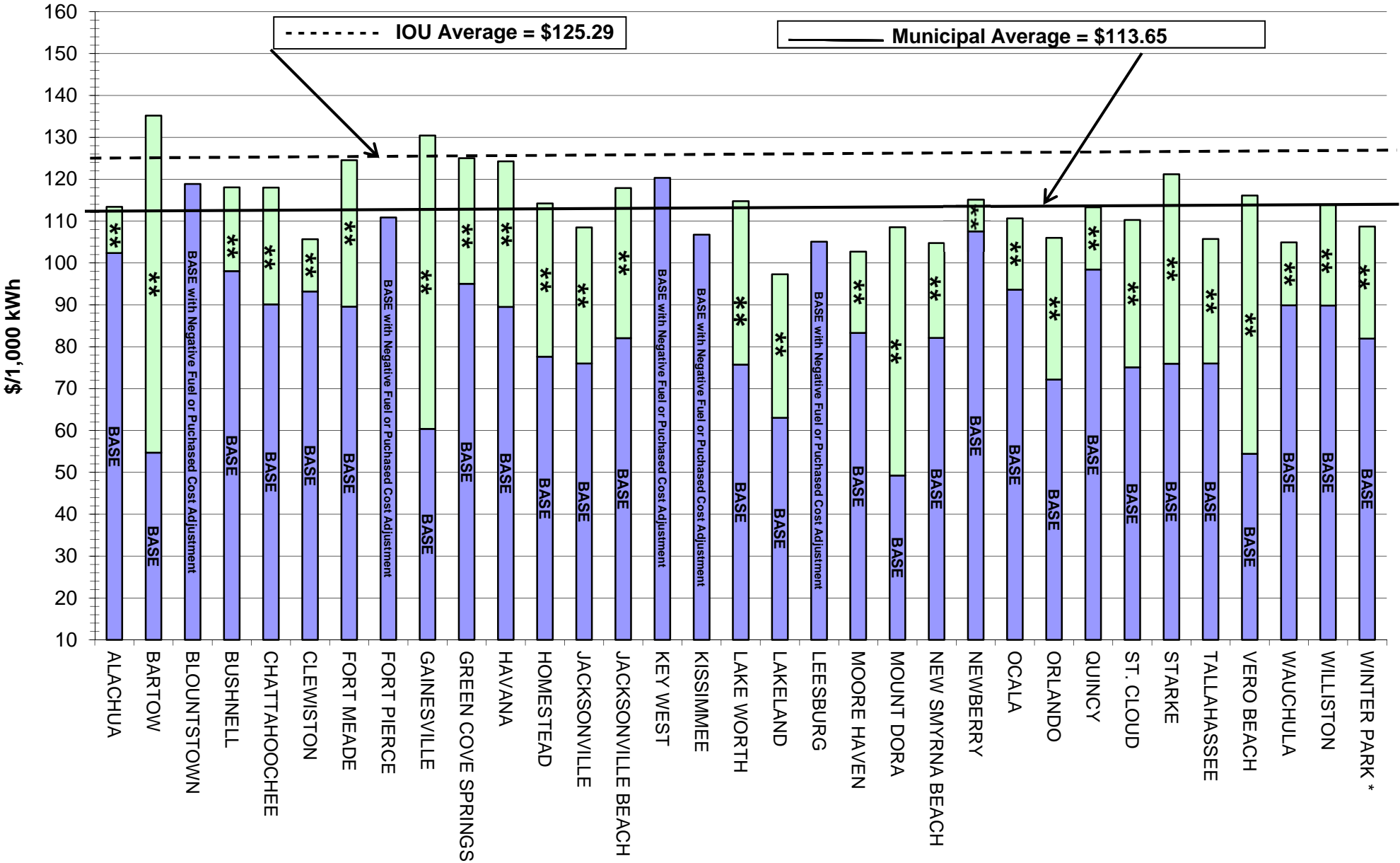


Residential Bill Comparison, February 2017

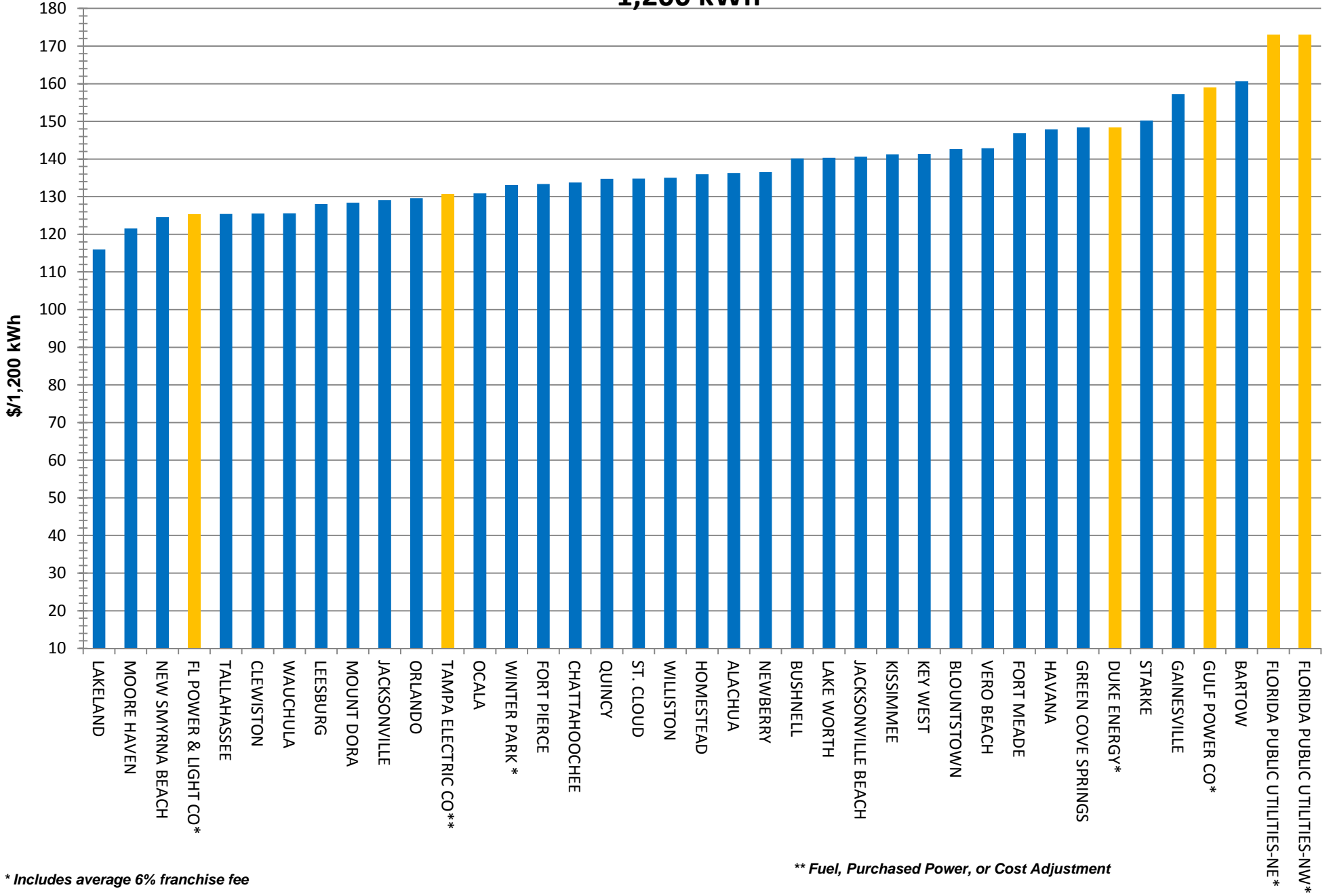
