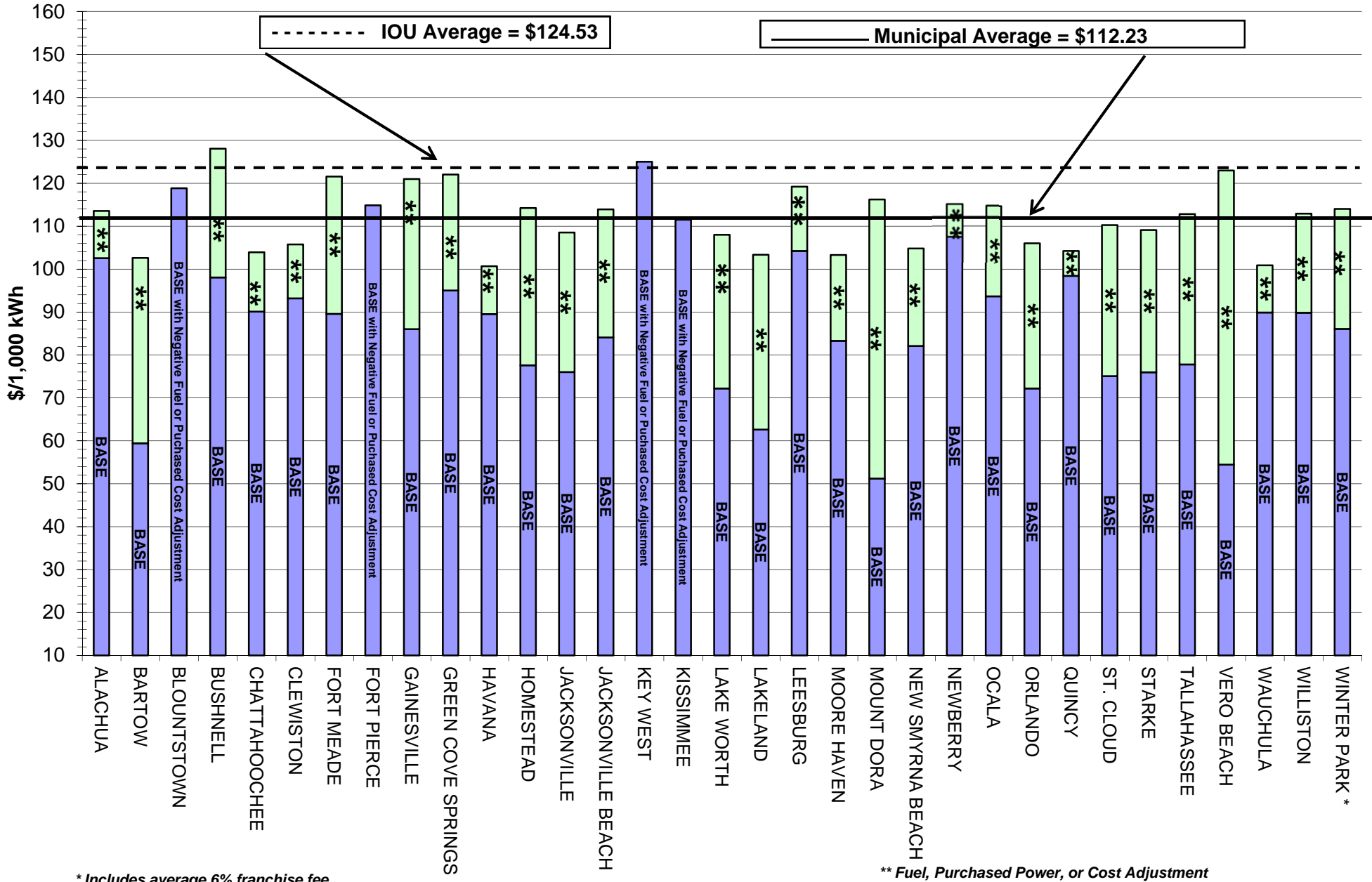


Residential Bill Comparison, August 2018

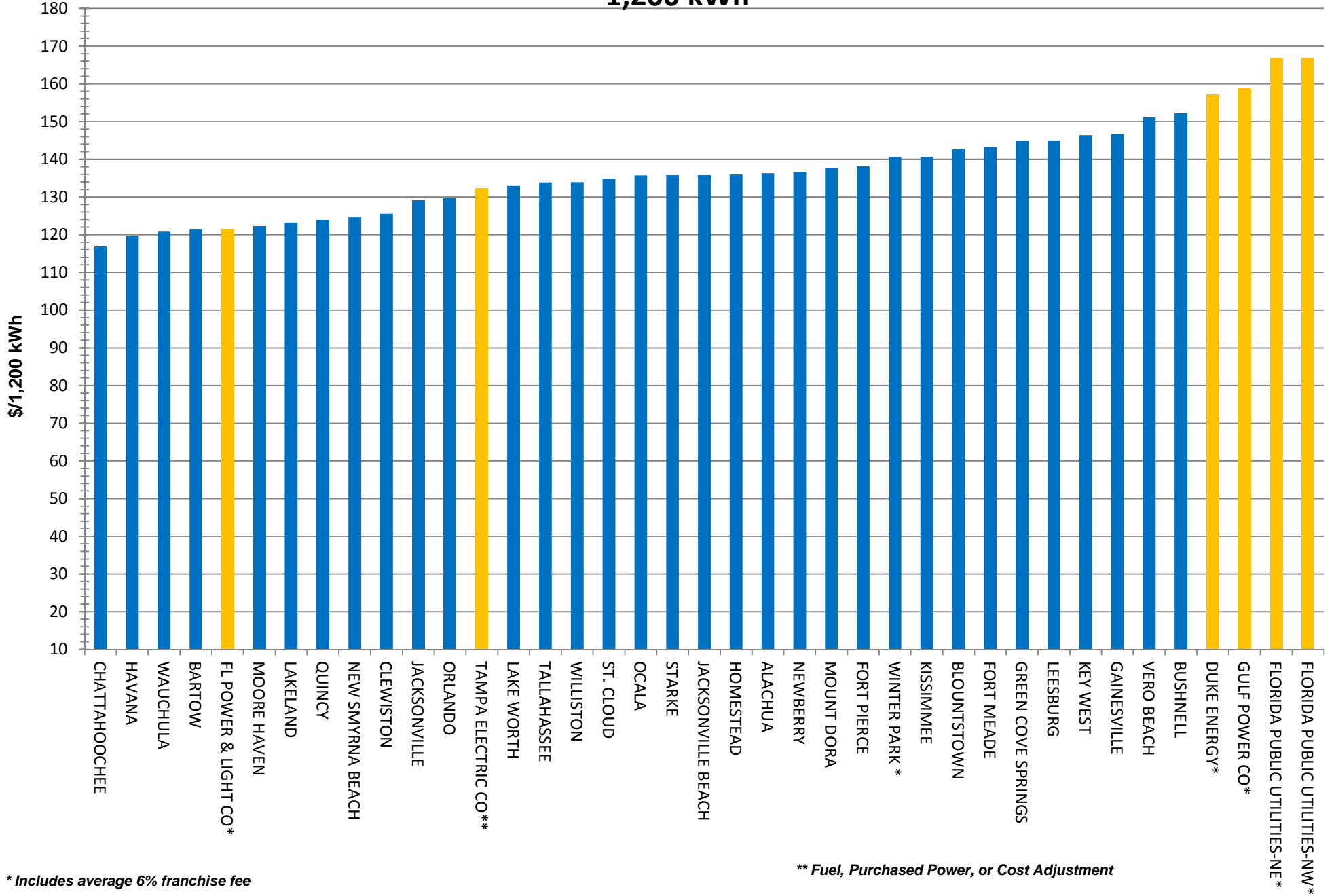
