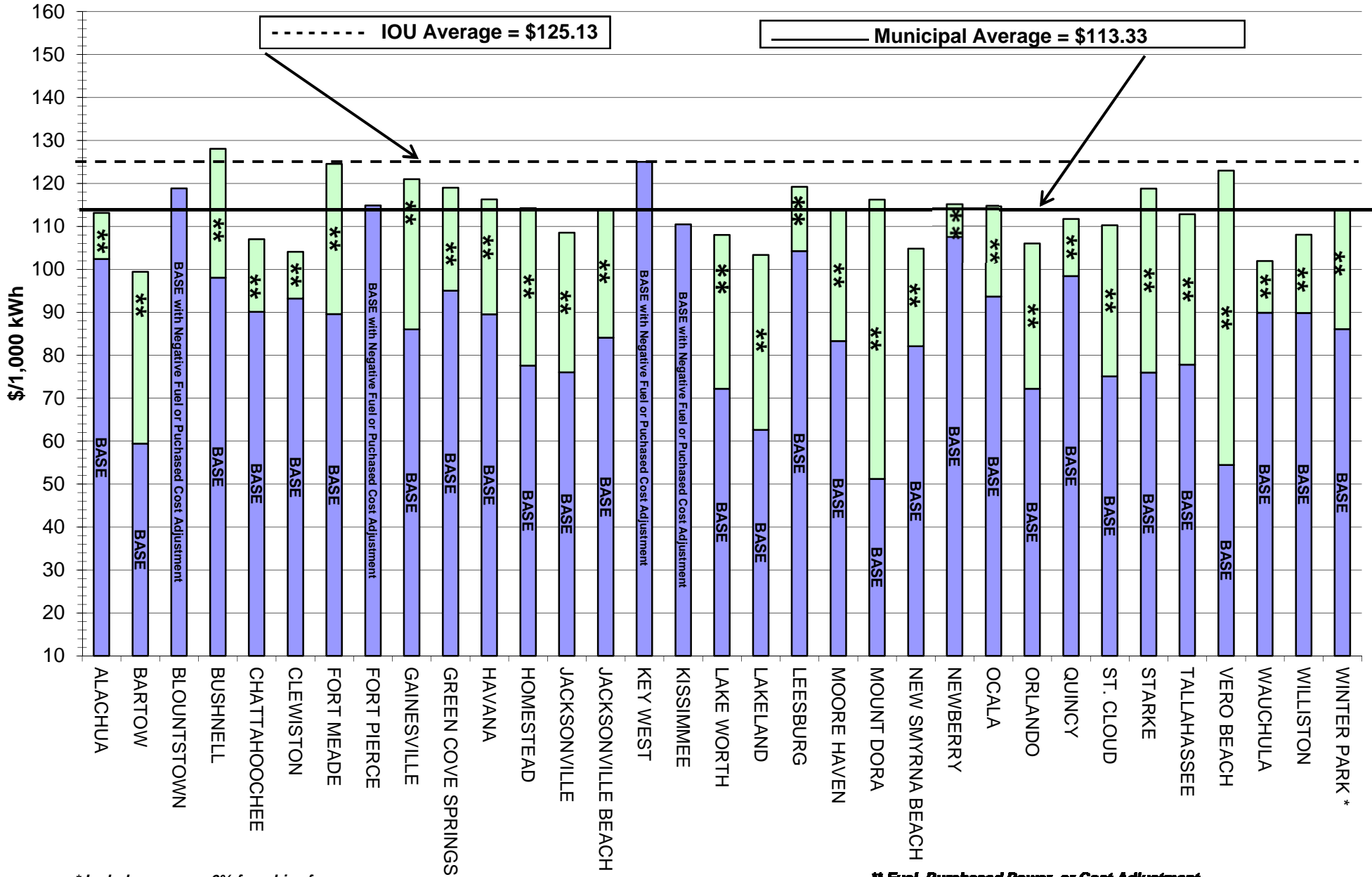


Residential Bill Comparison, May 2018

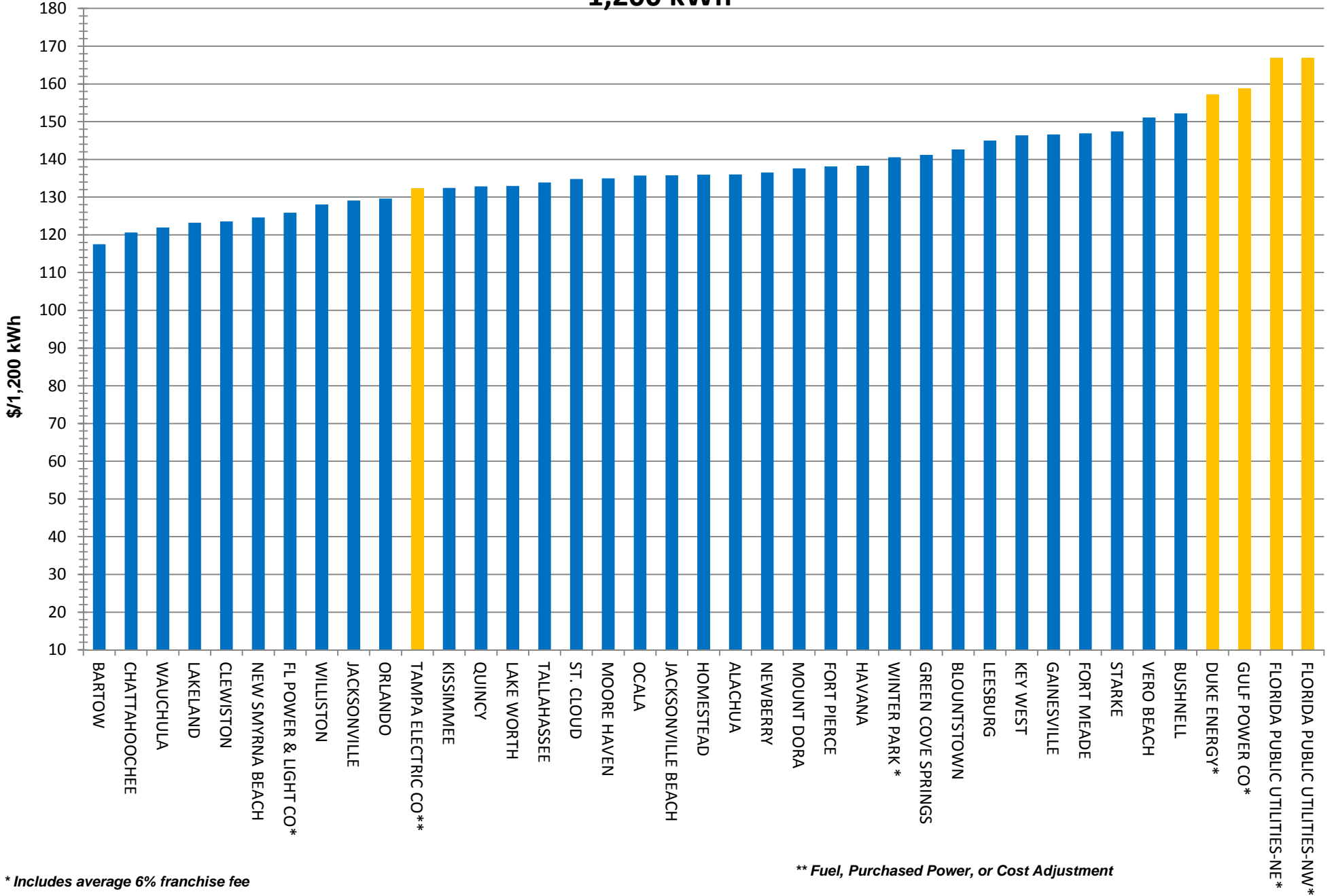
