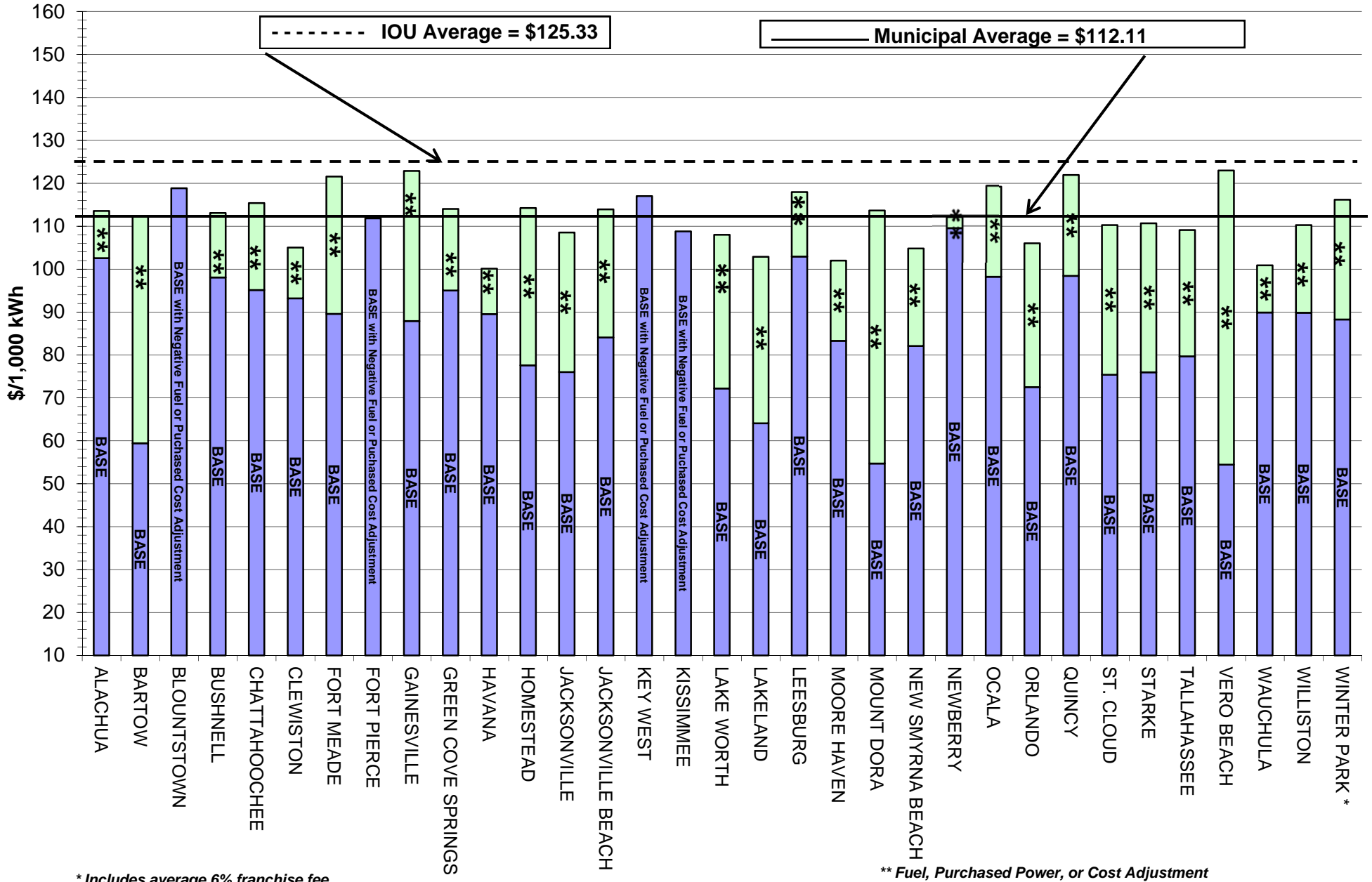


Residential Bill Comparison, November 2018

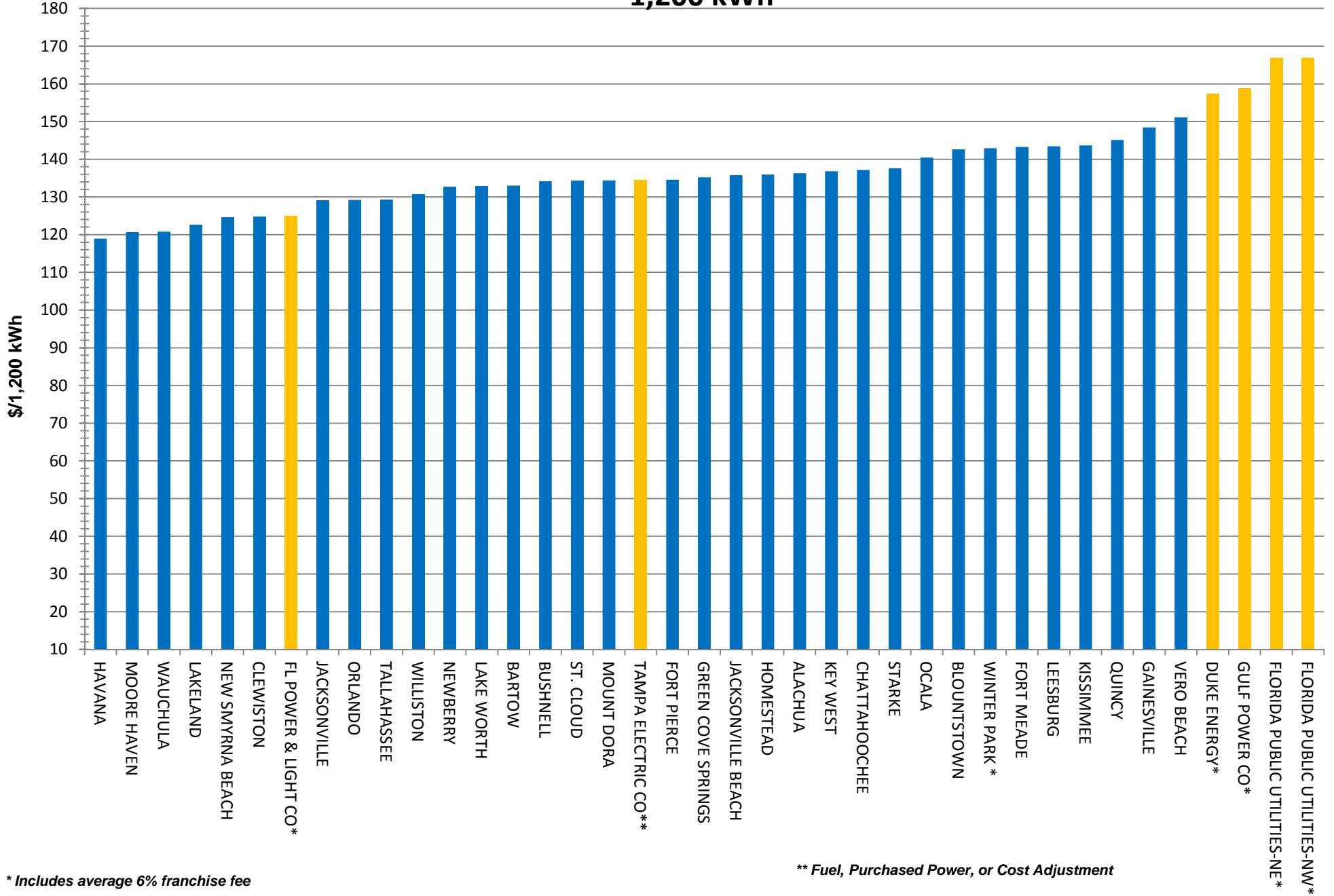
