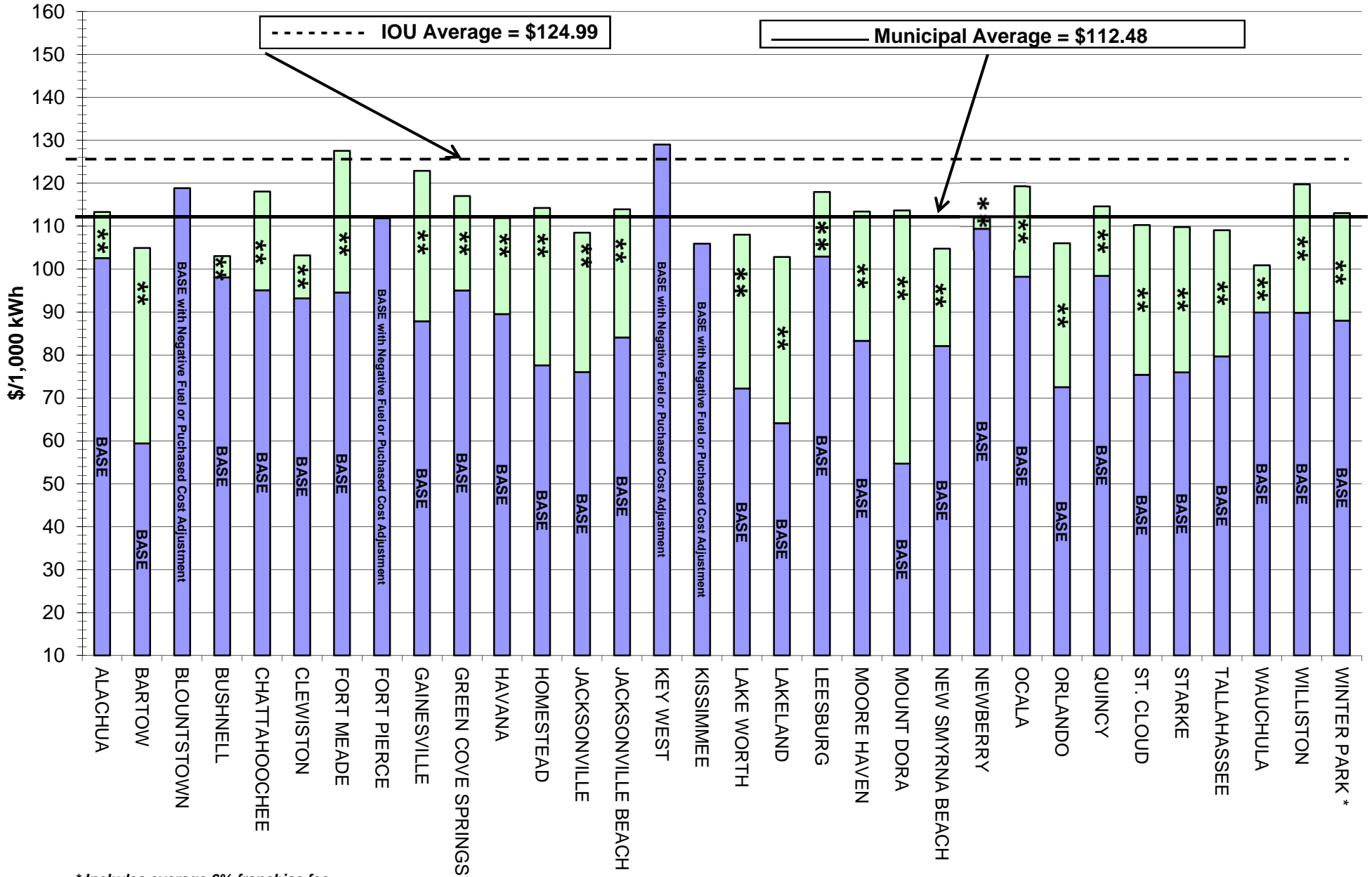


Residential Bill Comparison, February 2019

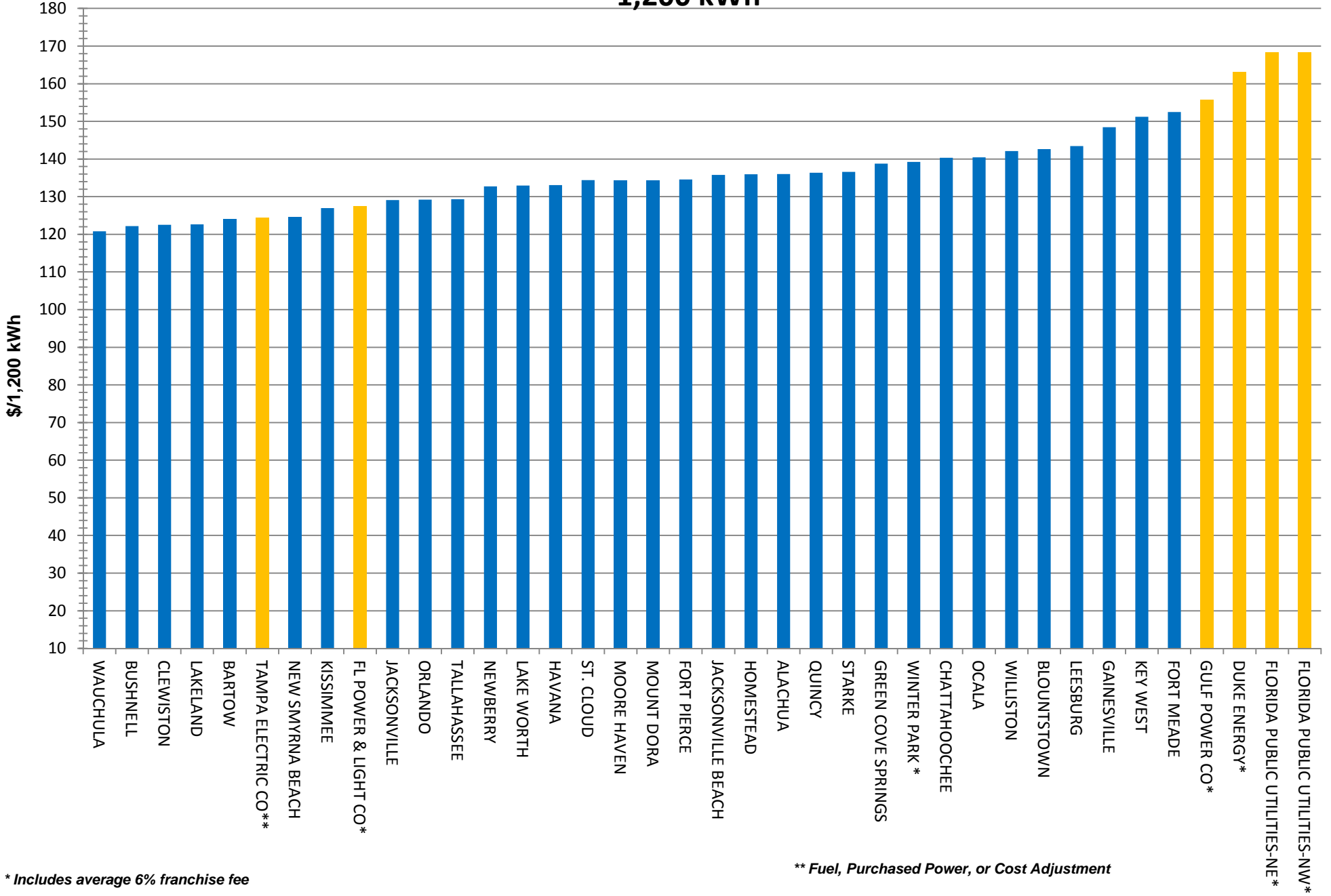
