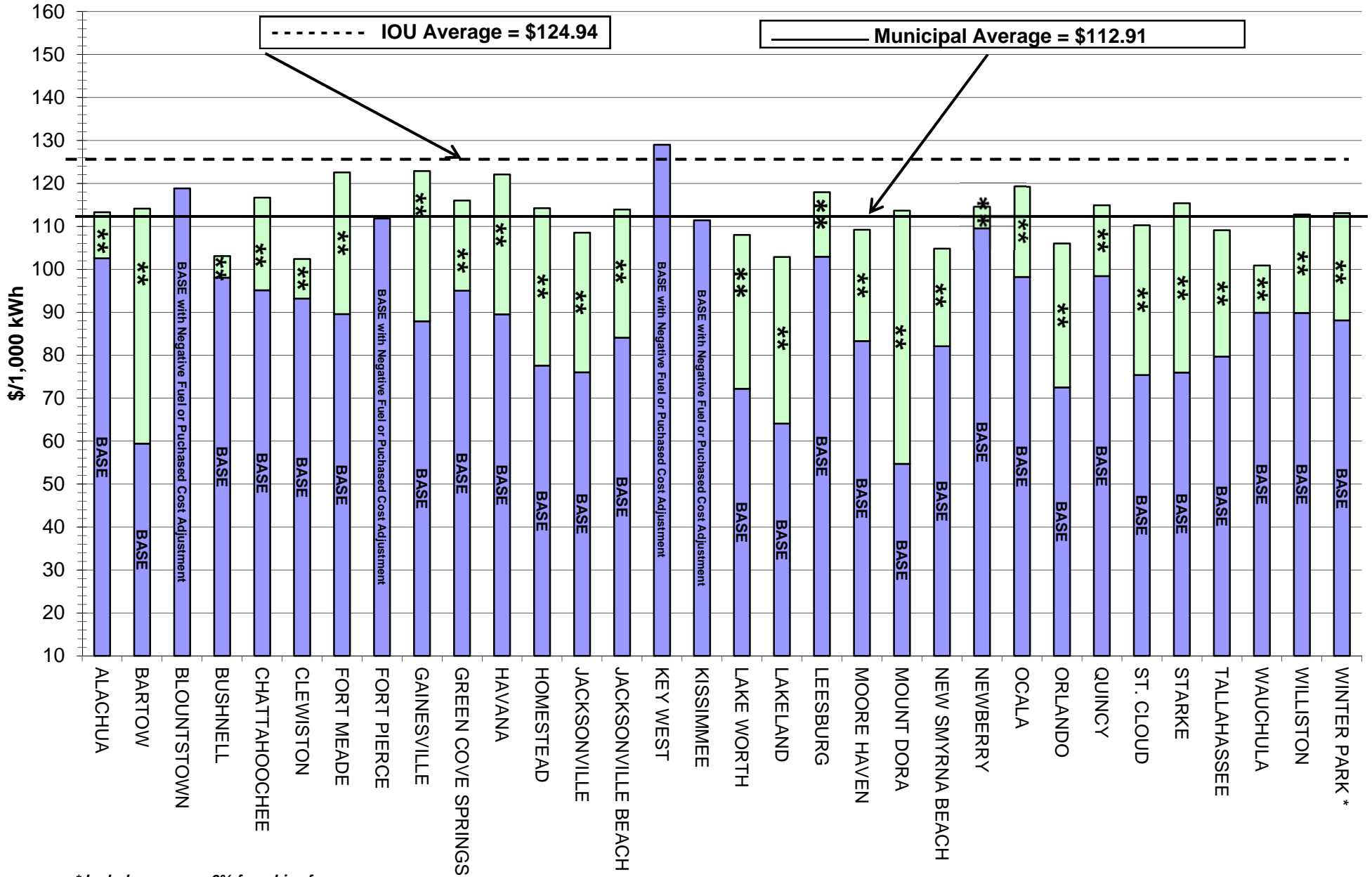


Residential Bill Comparison, January 2019

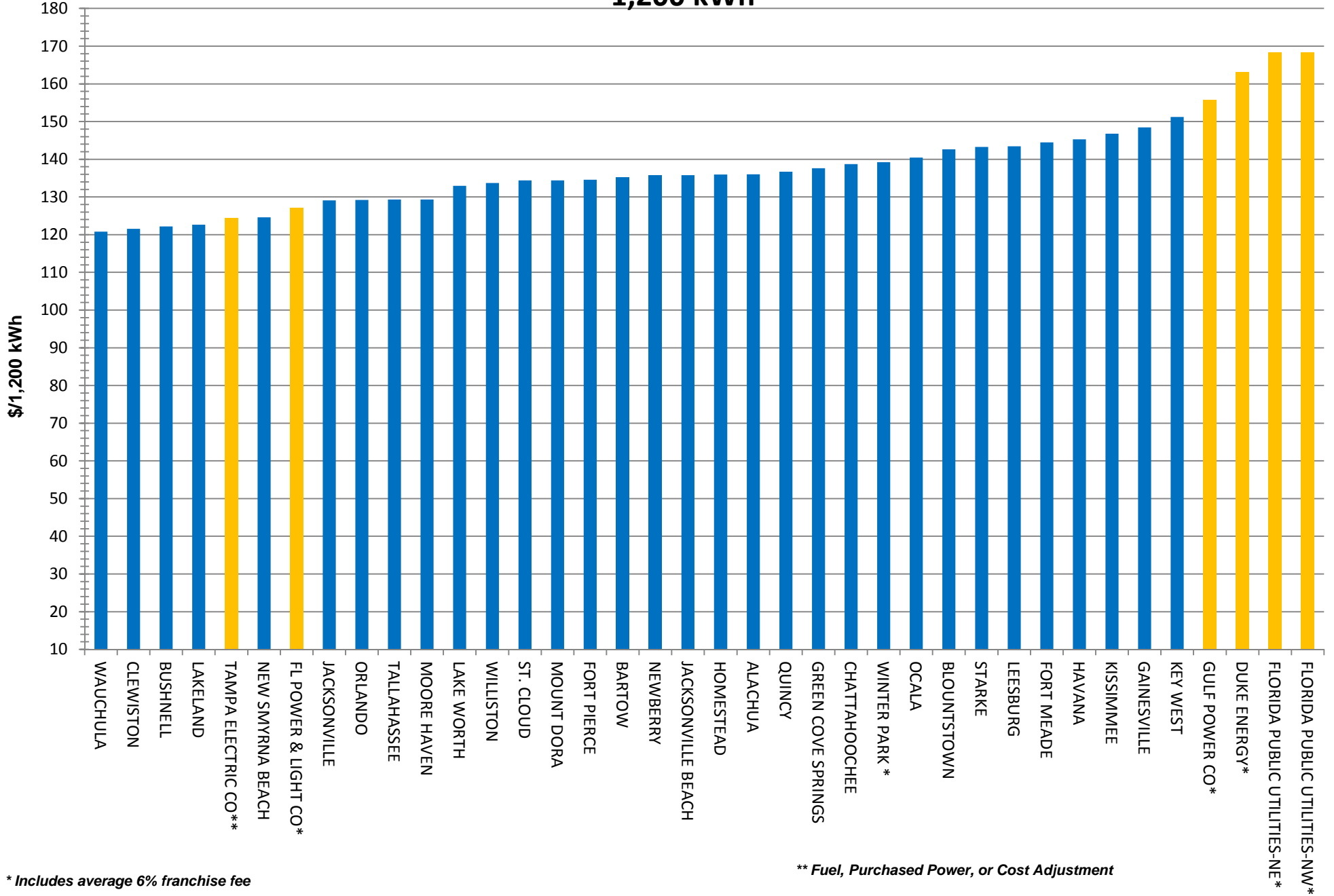
