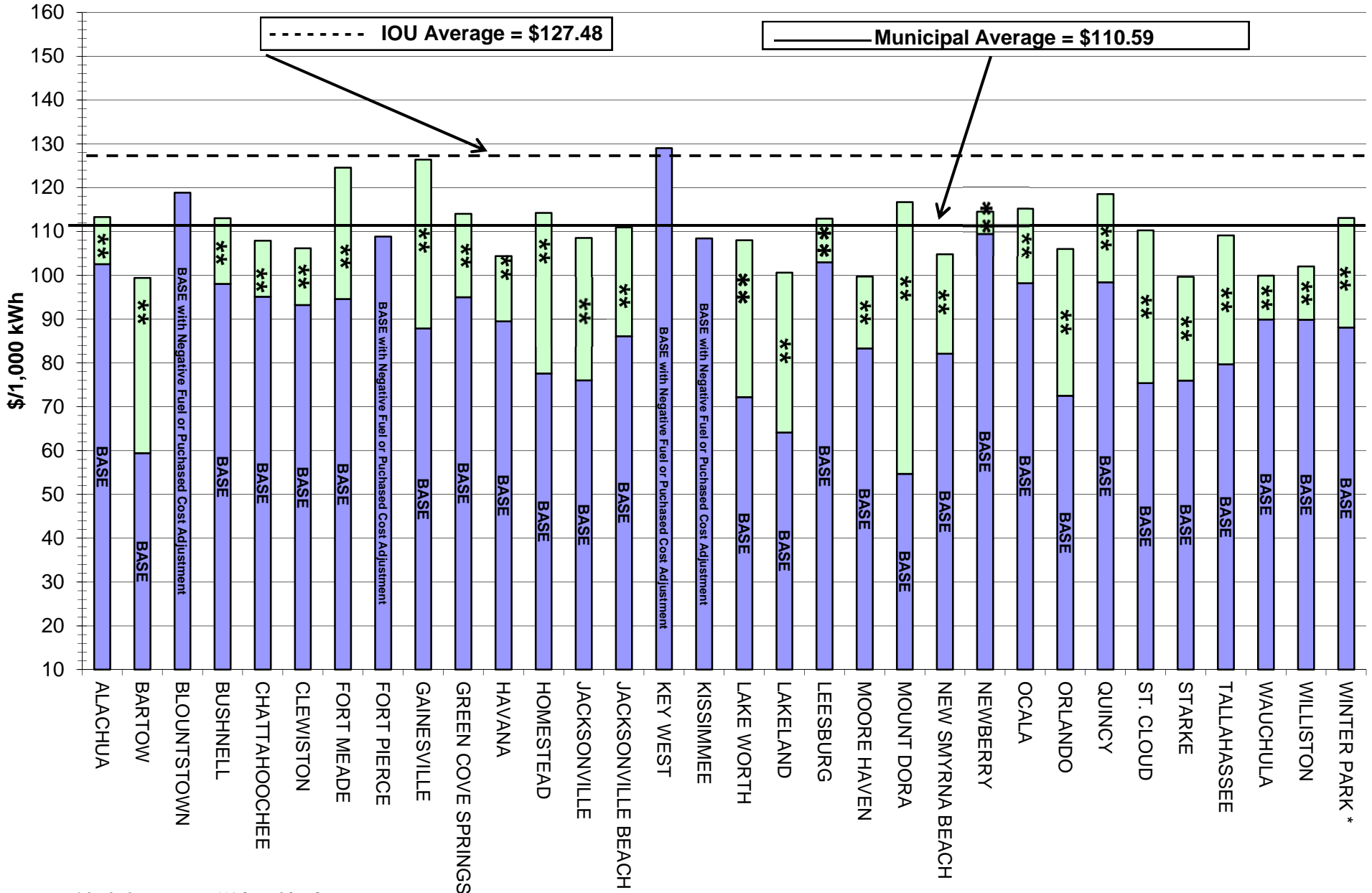


Residential Bill Comparison, September 2019

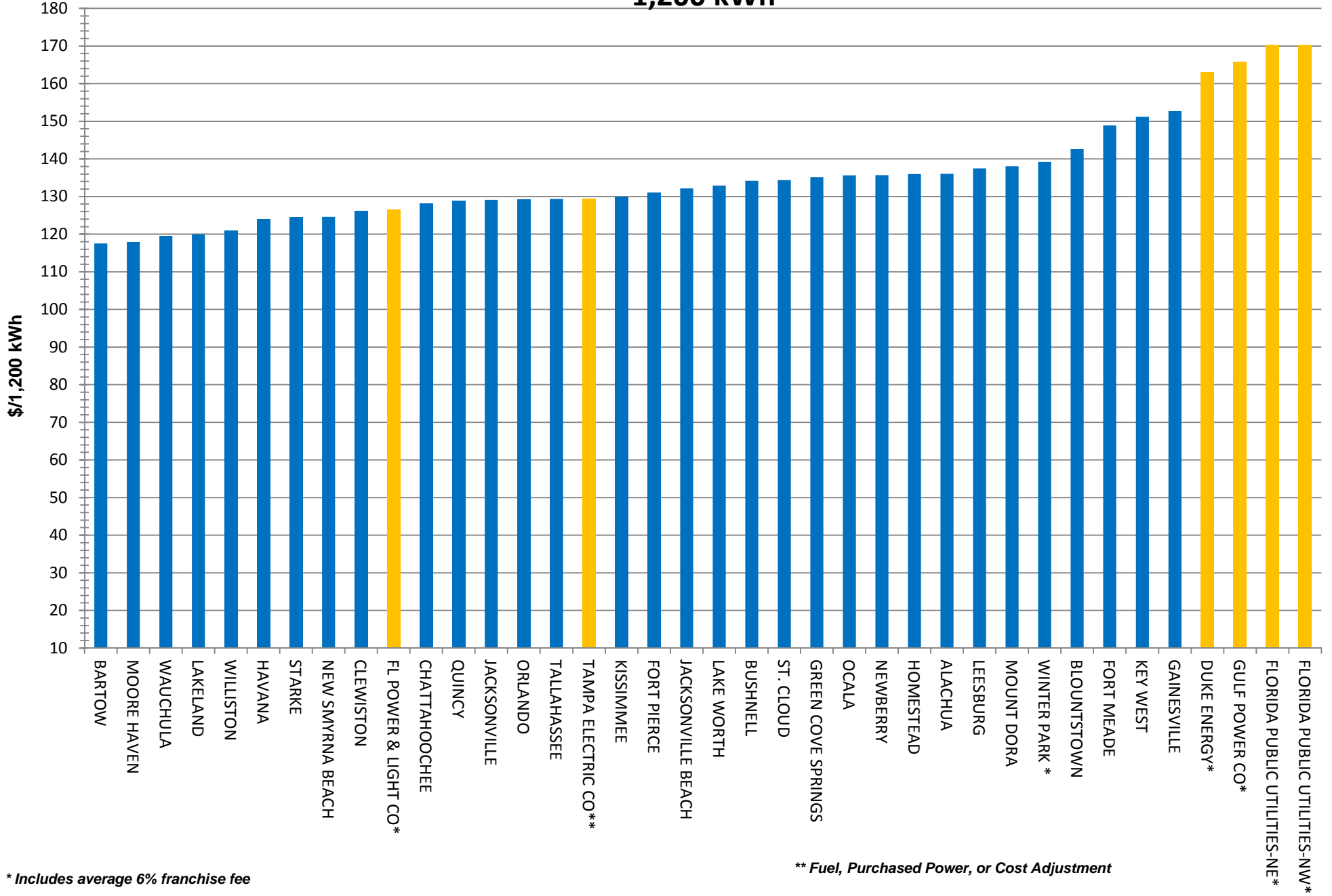
