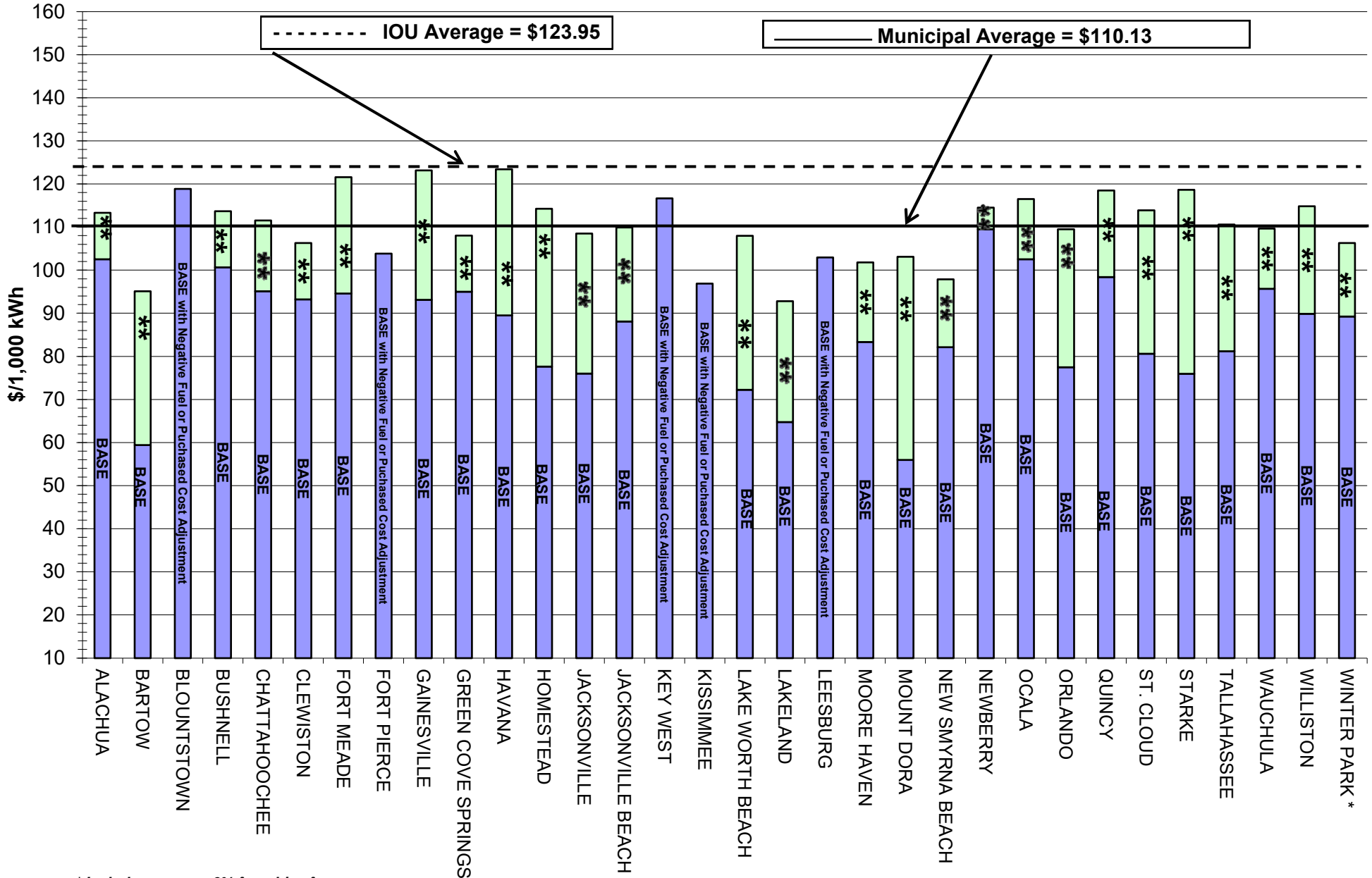


Residential Bill Comparison, July 2020

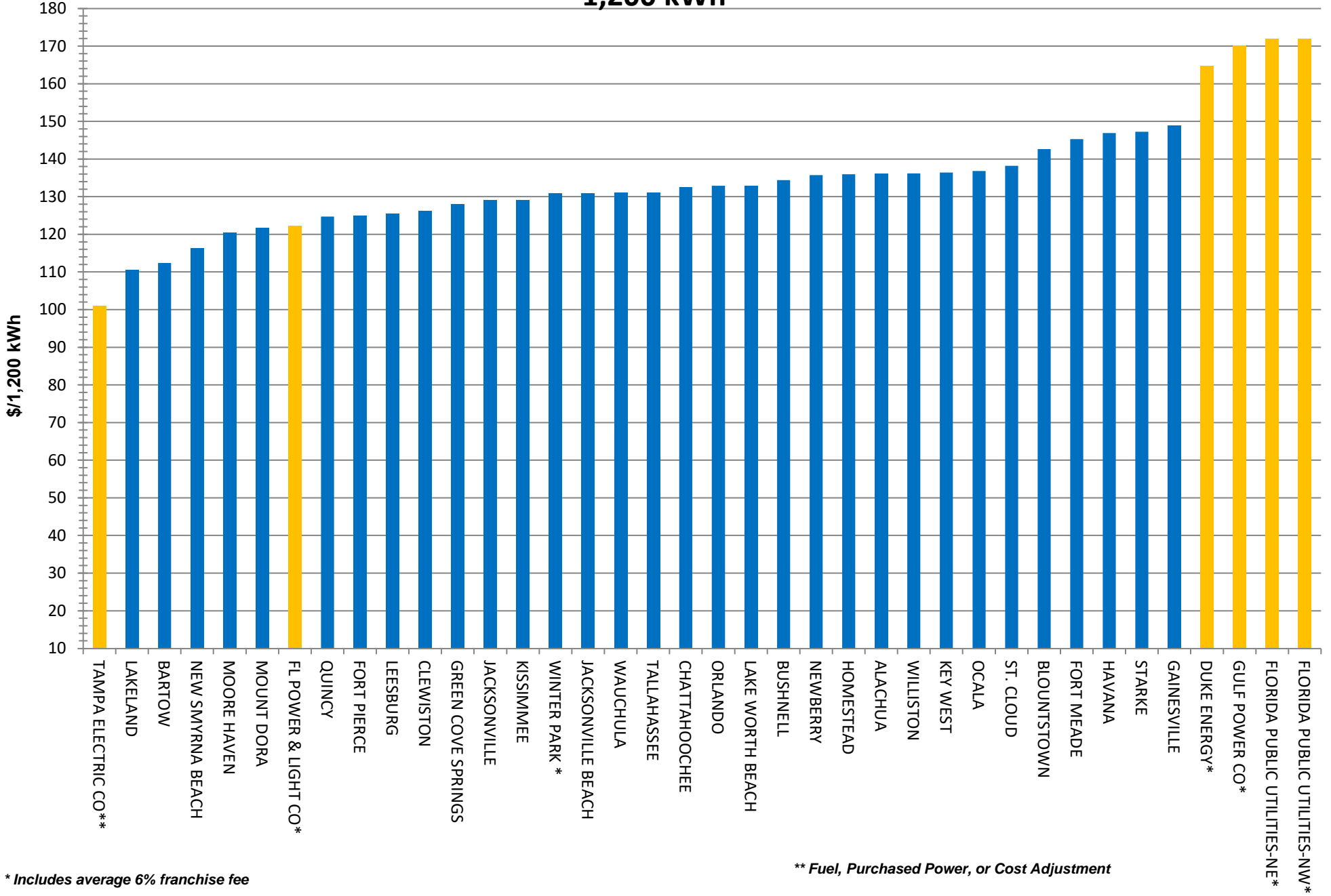
