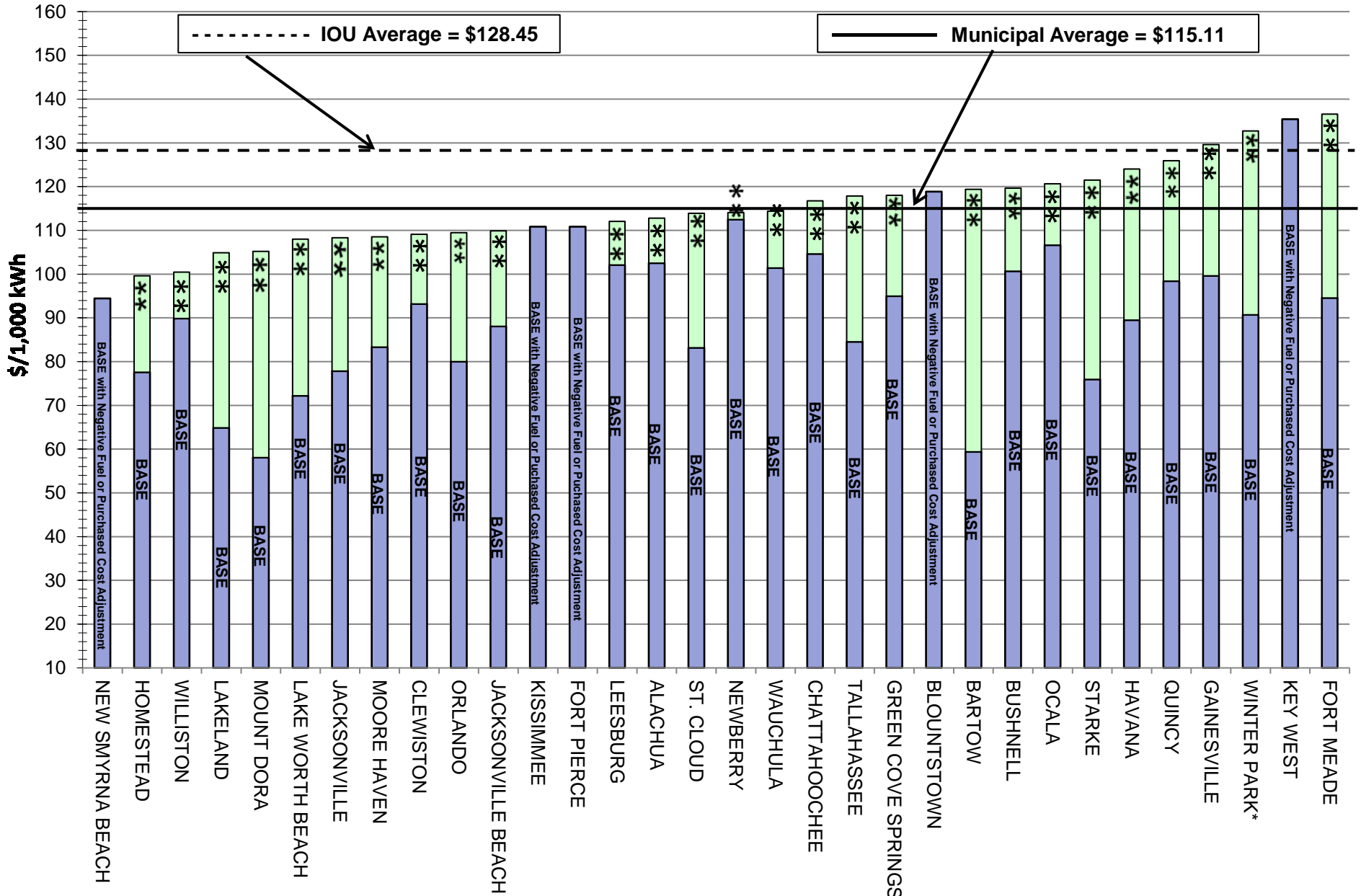


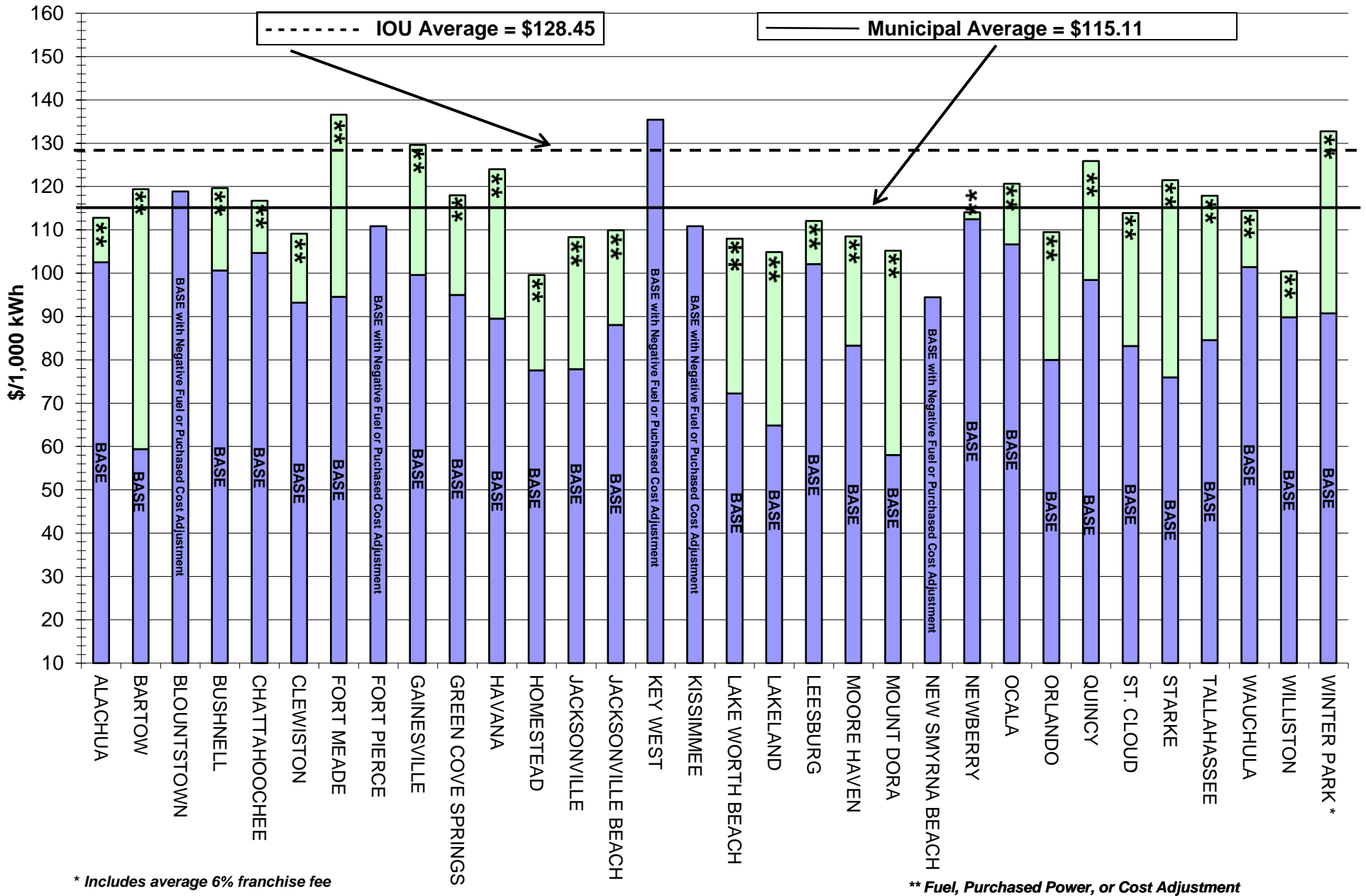
1000 kWh Residential Bill Comparison: October 2021, Lowest to Highest



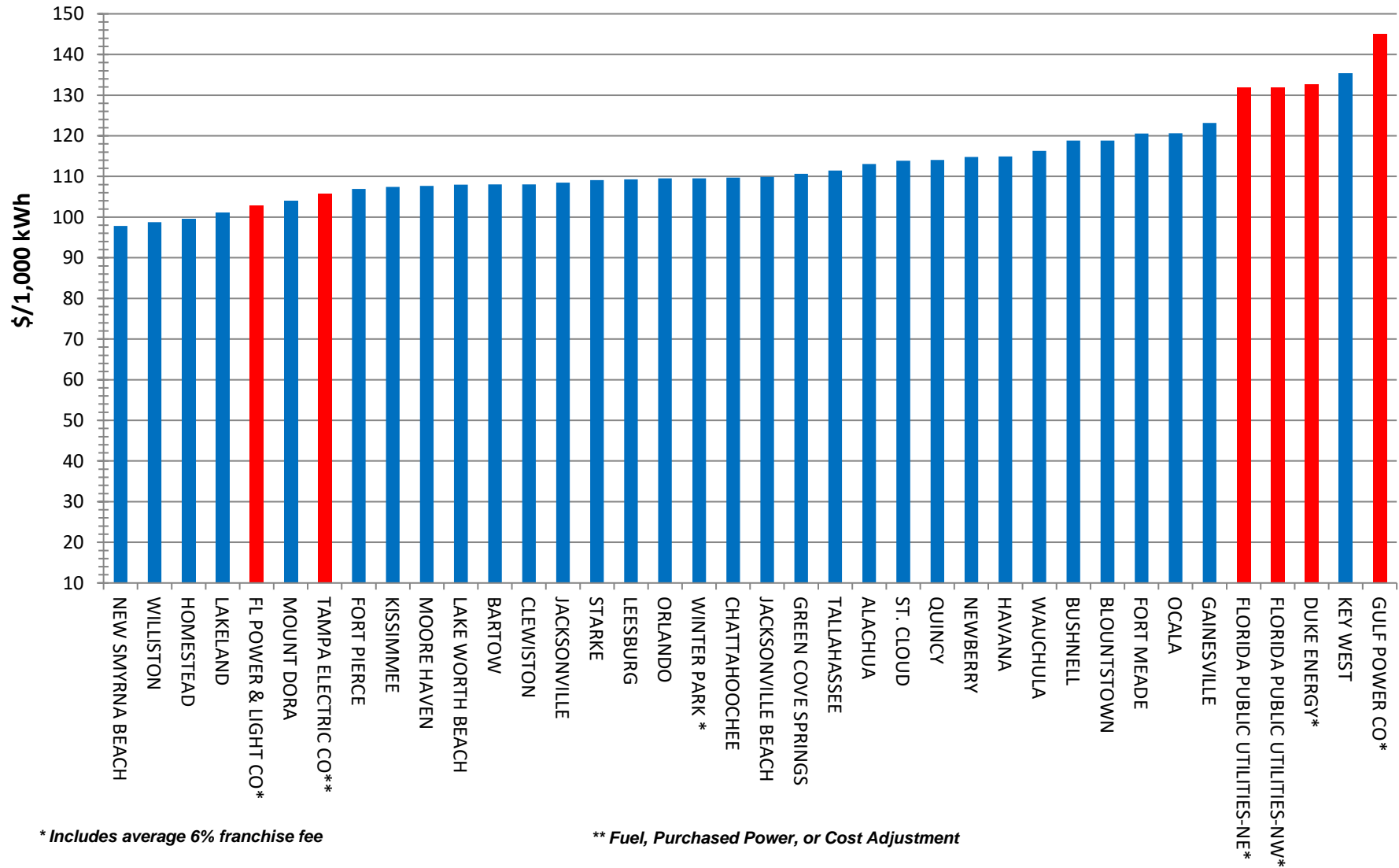

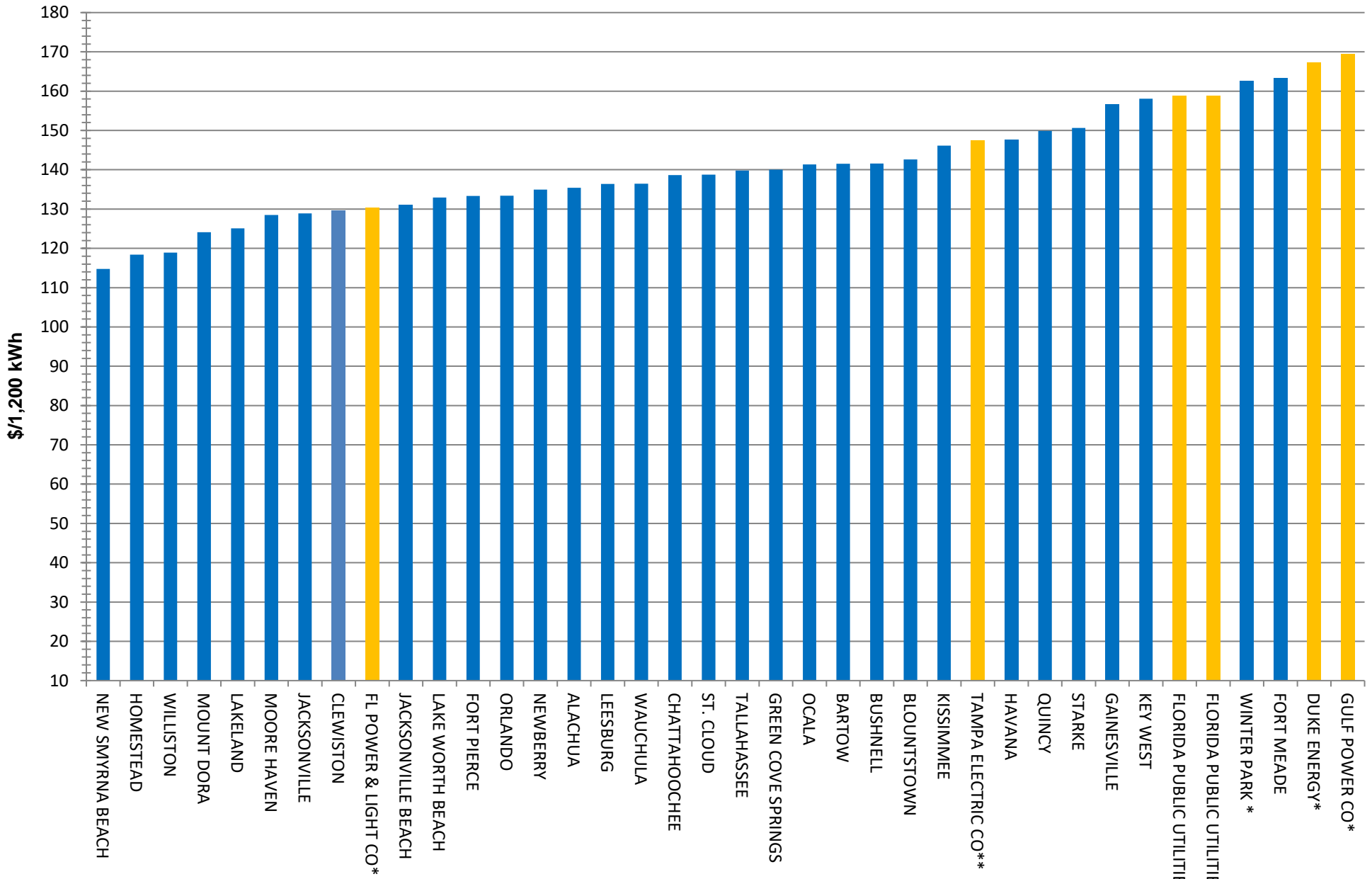
1000 kWh Residential Bill Comparison: October 2021, Alphabetical
