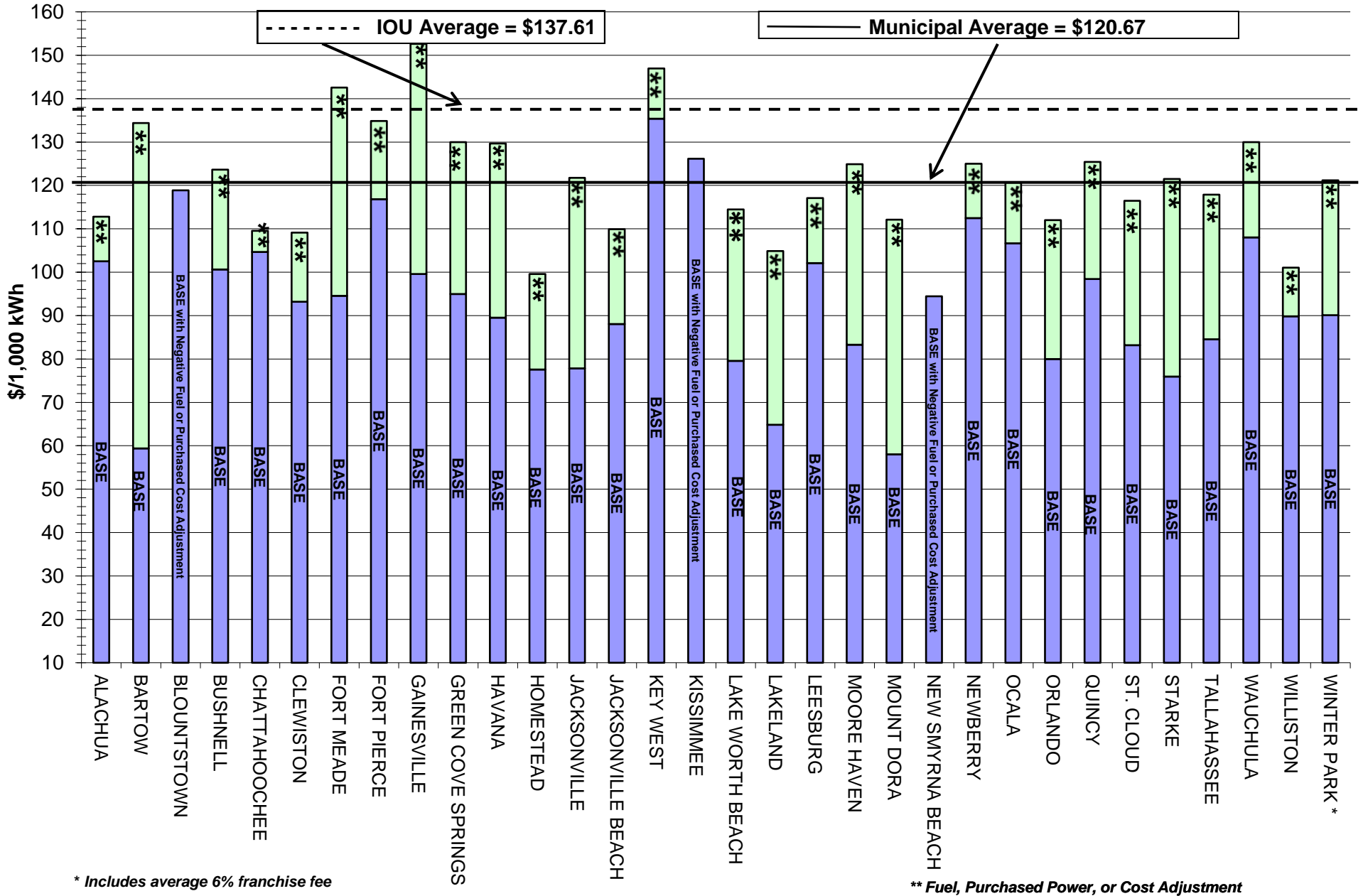
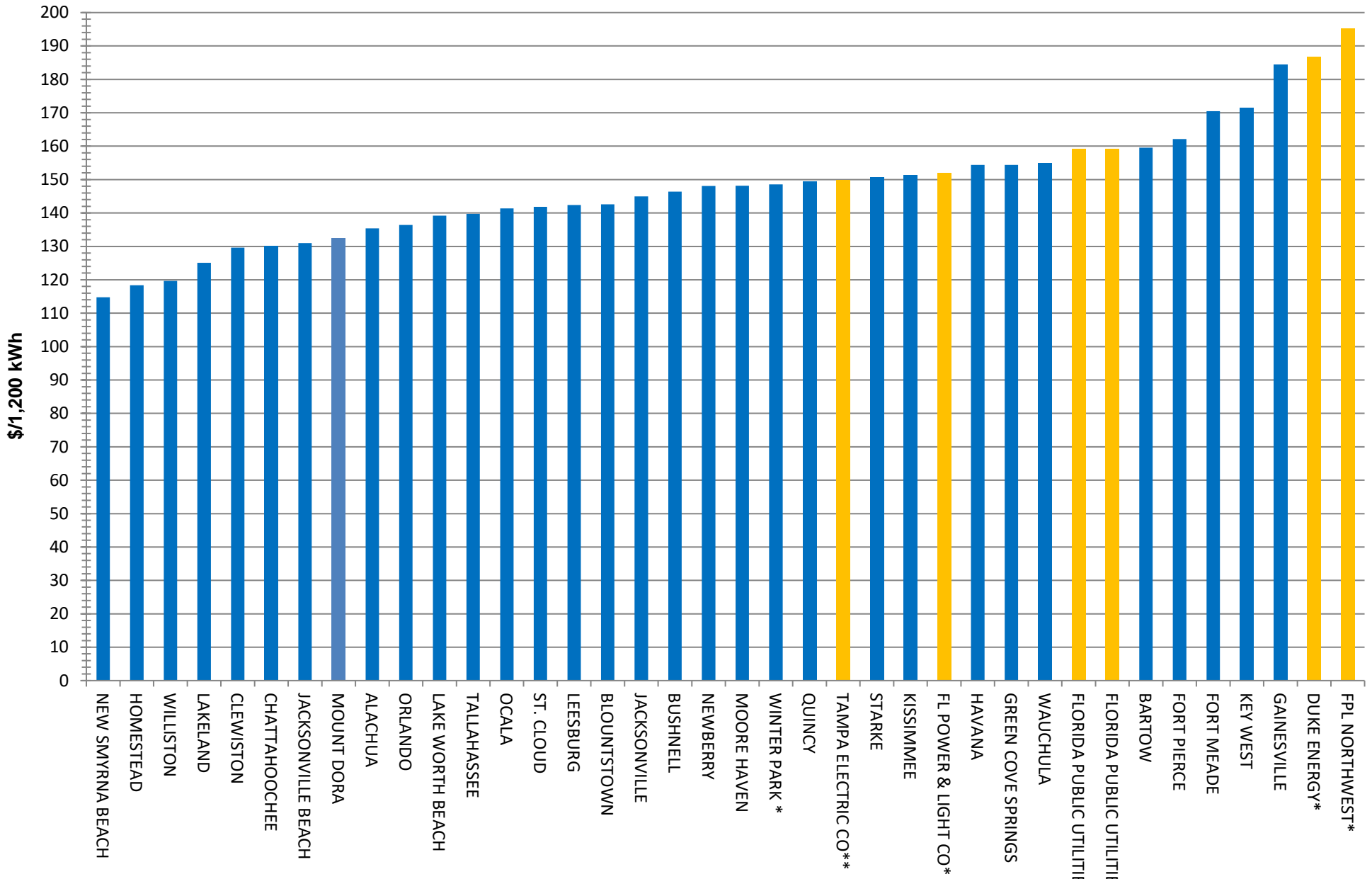


1,000 kWh Residential Bill Comparison: January 2022, Alphabetical
