Action Requested: Nominate your State Legislators for the Nonprofit Caucus

The National Nonprofit Legislative Caucus is an open, bipartisan, and bicameral group of legislators dedicated to supporting the work of charitable nonprofits and their communities. Its chair and champion, Maryland state Senator Cheryl Kagan is planning to promote the Caucus at the upcoming annual meeting of the National Conference of State Legislators. Before then, she is welcoming nominations of lawmakers who are 1) reasonable, 2) willing to work on a bipartisan basis, and, most importantly, 3) committed to working to advance policies that support the work of charitable nonprofits. If that criteria applies to the state representatives and/or senators in your district, please let us know.

## 2022 Giving USA Report

The 2022 Giving USA report was released earlier this morning, and findings showed that 2022 total giving dropped 3.4% in current dollars, or 10.5% after inflation. Total giving fell to just under \$500 billion last year. Donations from individuals declined by 6.4 percent in 2022 (a decline of 13.4 percent, adjusted for inflation). According to the report, this is the third time in forty years that donations did not increase year over year. The report also found that, in 2022, 64% of donations came from individuals and 21% from foundations. Click here for more information
