

CEUS/PDHS AND THE CONFERENCE

FRWA is an approved provider for Drinking Water, Wastewater, and Distribution License CEUs. We are also a provider of PDHs (Professional Development Hours) for Professional Engineers Area of Practice and Laws.

Conference CEU/PDH Information

- You must attend the Opening Session in addition to all of the classes in your chosen Track to qualify for the 1.2 CEUs/12 hours PDHs (Area of Practice).
- The Water Track is for Water/Distribution CEUs and PDHs only.
- The Wastewater Track and Wastewater Review is for Wastewater CEUs and PDHs
- The Drinking Water/Wastewater, Open, and Help Tracks may be applied to either your water, distribution, or wastewater license and PDHs.

Pre-Conference Bonus CEU/PDH Information

The Pre-Conference Exhibit Hall Training is considered bonus training. You **must** attend all day both Tuesday (July 30th) starting at 9:00 am and Wednesday (July 31st) until 3:00 pm in order to receive the bonus CEUs.

In order to earn the additional 0.5 CEUs you will be required to:

- Attend the Exhibit Hall Training on Monday, July 29th during the hours of 10:00 am-12:00 pm and 1:00 pm-4:00 pm.
- Sign up at the Exhibit Hall Training table where you will be assigned to a group.
- An FRWA staff member will be assigned to monitor your group for attendance.
- Stay with your group for the entire session as they stop by selected booths for fifteen-minute training sessions.
- CEU forms will be available for completion at the end of the sessions at 4:00 pm
- CEUs will be uploaded to the DEP website only after verification of your attendance on Tuesday and Wednesday.

FREQUENTLY ASKED QUESTIONS

May I attend only one day of the Conference and receive CEU/PDHs?

No, you must attend both Tuesday, July 30th (9:00 am-5:00 pm) and Wednesday, July 31st (8:00 am-3:00 pm) to receive the 1.2 CEU/PDHs offered. This includes attending the Opening Session on Tuesday, July 30th (9:00 am- 11:15 am), in order to earn the 1.2 CEU/12 PDHs.

Do I have to apply all of the CEUs I earn at the Conference to the same license?

No, you may apply the 0.5 CEUs received at the Exhibit Hall Training to one license and the 1.2 CEUs for attending on Tuesday and Wednesday to another license.

May I apply the 1.2 CEUs offered for the Drinking Water/Wastewater, Open, and Help Tracks on Tuesday and Wednesday to either water or wastewater licenses?

Yes, the Drinking Water/Wastewater, Open, and Help Tracks are cross training for water or wastewater operators so it covers both licenses.

Can I count part of the Drinking Water/Wastewater Track as water and part as wastewater?

No, the 1.2 CEUs earned can only be applied to one license.

If I am not interested in receiving CEUs/PDHs, then may I attend any session at any time?

Yes. Although we must comply with the CEU program guidelines, attendees not sitting for CEUs are welcome to attend any breakout sessions offered. You are required to pay the registration fee even if you do not wish

to earn CEUs to cover the costs of the Conference.
