### **Utilities Supervisor**

A Water and Wastewater Supervisor oversees the operation, maintenance, and repair of water and wastewater systems, ensuring compliance with regulations and providing safe, reliable service. This role involves supervising staff, managing daily operations, and implementing improvements to existing infrastructure.

# Key Responsibilities:

- Directing and coordinating the work of crews involved in water distribution, wastewater collection, and treatment plant operations.

- Collecting and testing water and sewage samples.
- o Operating and maintaining treatment plant equipment.
- Performing concrete work around water and sewer infrastructure.
- Maintaining and repairing reservoirs, pump stations, and other facilities.
- Assisting in the training of new personnel.
- o Participating in hydro-jetting and other excavation work.
- Working with hand and power tools, including jackhammers, pipe locators, and welding equipment.
