This class is intended for those applicants who have not completed their educational requirements for the State of Florida, Certified Water Distribution Operator Examination. This class will provide a Certificate of Completion that will meet the educational requirements for the Level 1, 2 and Level 3, State of Florida, Water Distribution Operator Examination.

Registration must be submitted to FRWA if you wish to attend the training class. There is an Administrative Fee of \$35.00 for FRWA members and \$65.00 for non-members. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$85.00 for members and \$115.00 for non-members. From I-10 take exit 17 onto US 90 toward Pace/Pensacola. Travel 0.30 miles and then turn left onto Scenic Hwy/US 90 E. Travel 2.29 miles and then turn left onto Addison Dr. Travel 0.12 miles and take 1st left onto Grow Dr. In 0.09 miles take the 1st right onto Copter Rd. Then travel 0.53 miles and turn right onto Sturdevant St. In 0.15 miles the destination will be on your left. **Park on side of building or across the street, Do not park in front of the building.**
