REGISTRATION INFORMATION

Registration must be submitted to FRWA if you wish to attend the training class. There is an Administrative Fee of \$35.00 for FRWA members and \$65.00 for non- members. You may pay by credit card online or you may mail your payment to FRWA at 2970 Wellington Circle, Tallahassee FL. 32309. FRWA must receive your written registration in order to reserve your seat. Payment may be made by organization check, cashier’s check, and money order, Visa or MasterCard. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$85.00 for members and \$115.00 for non-members. No payments will be accepted at the seminar or over the phone. This class is subject to cancellation if registration is less than 10 attendees within 5 working days of the class. From the North: on I-75 merge onto I-275 N. via Exit 228 toward St. Petersburg, travel 1.7 miles and then take US-41 Exit 2, toward Palmetto/Bradenton, travel 0.29 miles then keep left to take the ramp toward Palmetto/Bradenton, Turn left onto US-41 S/FL – 45/ US Highway 41 N. travel 7.56 miles then take US -41 ramp travel 2.25 miles and then stay straight onto FL-684/ Cortez Rd. W. travel 3.16 miles and turn left onto 66th St. W. then in 0.5 miles the destination is on the right.

From the South: on I-75 take FL-70 W. Exit 217B toward Bradenton, travel 0.36 miles and merge onto 53rd Ave. E. travel 10.46 miles and then turn onto 66th St. W. the destination is on the left.
