REGISTRATION INFORMATION

Registration must be submitted to FRWA if you wish to attend the training class. There is an Administrative Fee of \$35.00 for FRWA members and \$65.00 for non- members. You may pay by credit card online or you may mail your payment to FRWA at 2970 Wellington Circle, Tallahassee FL. 32309. FRWA must receive your written registration in order to reserve your seat. Payment may be made by organization check, cashier’s check, and money order, Visa or MasterCard. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$85.00 for members and \$115.00 for non-members. No payments will be accepted at the seminar or over the phone. This class is subject to cancellation if registration is less than 10 attendees within 5 working days of the class. If the class is cancelled, FRWA will notify you and may only refund one half of your registration fee due to administrative cost. Please be sure to provide your correct email address on the registration form so we can contact you in case of cancellation. 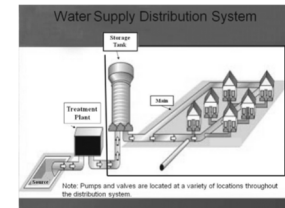

From I-10 West, take exit 331 towards Freeport, travel 14 miles and then turn left onto State Highway 20, Travel 26.77 miles and then turn right onto Highway 77, travel 13.33 miles and then turn left onto E. 3rd, St. travel 0.02 miles and then turn right onto Pennsylvania Ave. then travel 0.09 miles and turn 1st right onto E. 4th Ave. then travel 0.05 miles and turn 1st right onto Ohio Ave. then travel 0.08 miles and you will reach your destination.

From I-10 East, take exit 130 onto U.S. 231 towards Panama City, travel 40.47 miles then turn slight right onto E. Highway 390, then travel 4.29 miles and turn right onto Ohio Ave. then in 1.05 miles you will reach your destination.
