## CEU INFORMATION

This class provides 1.0 CEUs for drinking water, wastewater, or distribution system and 1.0 PDHs. Registration must be submitted to FRWA if you wish to attend the training class. There is no charge for those not wishing to receive CEUs, however if you wish to receive CEUs there is an Administrative Fee of \$50.00 for FRWA members and \$80.00 for non-members, \$90 for PDHs. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$100.00 for members and \$130.00 for non-members. No payments will be accepted at the seminar or over the phone. FRWA must receive your written registration in order to reserve your seat.

CEU forms will be handed out during class to those wishing to obtain CEUs. These forms are the only proof of attendance that will be recognized by FRWA as eligibility for CEUs to be awarded. Due to problems associated with CEU forms, all forms must be obtained, completed, and submitted at the end of each session to be accepted.

You must register as a PE in order to receive a Professional Engineer PDH certificate of attendance. The certificate will be issued and delivered at the end of the class to professional engineers that are paid in full.
