CEU INFORMATION

This class provides 0.6 CEUs for drinking water, wastewater, or distribution system and 6.0 PDHs. Registration must be submitted to FRWA if you wish to attend the training class. There is no charge for those not wishing to receive CEUs, however if you wish to receive CEUs there is an Administrative Fee of \$50.00 for FRWA members and \$80.00 for non- members, \$90 for PDHs. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$100.00 for members and \$130.00 for non-members. No payments will be accepted at the seminar or over the phone. FRWA must receive your written registration in order to reserve your seat.

Due to problems associated with CEU forms, all forms must be obtained, completed, and submitted at the end of each session to be accepted.
