Directions from North 301: Travel to Waldo, FL and take the right ramp onto FL-24 for 24.7 miles and merge onto SE Williston Rd for 6.3 miles and turn right onto SW 62nd Ave. for 1.3 miles, turn left on FL-24 for .8 miles then turn right onto SW 75th St/Tower Rd., turn right onto SW 41st Pl, merge onto 63rd Blvd., pass the Treatment Plant and TREEO's entrance is on the left .

Directions from South I-75: Take exit 384, turn left on FL-24 for 2.5 miles then turn right onto SW 75th St/Tower Rd., turn right onto SW 41st Pl, merge into 63rd Blvd., pass the Treatment Plant and TREEO's entrance is on the left .
