CEU INFORMATION

Travel 2.3 miles and then turn left onto Addison Dr. Travel 0.7 miles and take 1st left onto Grow Dr. In 0.10 miles take the 1st right onto Copter Rd. Then travel 0.53 miles and turn right onto Sturdevant St. In 0.15 miles the destination will be on your left. **Park on side of building or across the street, Do not park in front of the building.**
