REGISTRATION INFORMATION

Registration must be submitted to FRWA if you wish to attend the training class. There is an Administrative Fee of \$50.00 for FRWA members and \$80.00 for non- members. You may pay by credit card online or you may mail your payment to FRWA at 2970 Wellington Circle, Tallahassee FL. 32309. FRWA must receive your written registration in order to reserve your seat. Payment may be made by organization check, cashier's check, and money order, Visa or MasterCard. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$100.00 for members and \$130.00 for non-members. No payments will be accepted at the seminar or over the phone. This class is subject to cancellation if registration is less than 10 attendees within 5 working days of the class. If the class is cancelled, FRWA will notify you and may only refund one half of your registration fee due to administrative cost.
