CEU INFORMATION

This class provides 0.5 CEUs for wastewater or drinking water operators and 5.0 PDHs for Engineers. Registration must be submitted to FRWA if you wish to attend the training class. There is no charge for those not wishing to receive CEUs, however if you wish to receive CEUs there is an Administrative Fee of \$35.00 for FRWA members and \$65.00 for non-members, and \$75 for PDHs. Payment may be made by organization check, cashier’s check, and money order, Visa or MasterCard. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$85.00 for members and \$115.00 for non-members.
