CEU INFORMATION

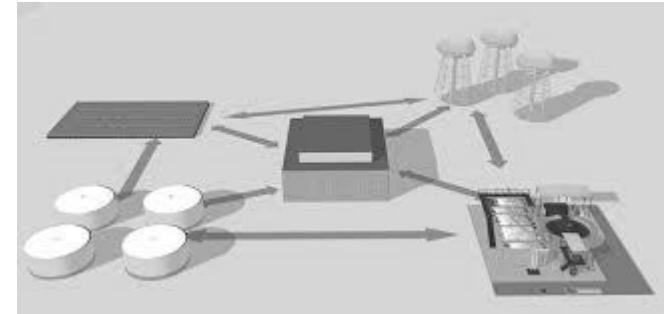
