Registration must be submitted to FRWA if you wish to attend the training class. There is an Administrative Fee of \$35.00 for FRWA members and \$65.00 for non-members. Members who host the training class will pay a reduced rate of \$20.00 for their attendees. Payment may be made by organization check, cashier's check, money order, or online by credit card. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$85.00 for members and \$115.00 for non-members. FRWA must receive your written registration in order to reserve your seat. This class is subject to cancellation if registration is less than 10 attendees within 5 working days of the class.
