#### SEMINAR OBJECTIVE

FRWA is holding seminars throughout the state to assist systems, such as yours, to return to compliance.

This workshop will assist participants in completing an accurate Lead Service Line Inventory to bring water systems into compliance. You will be instructed in the necessary information to go into the Inventory and work together with coaches on preparing a Lead Service Line Inventory for submittal to DEP or the Approved County Health Department.

To participate in the class, you will need to bring:

- Your PWSID and the number of service lines
- A laptop and a thumb drive
- A list of all customer addresses for your water system
  - A map of the service area served by your water system
  - A copy of your Lead and Copper Sampling Plan
  - The most recent MOR submitted
