## CEU INFORMATION

This class provides 0.6 CEUs for Drinking Water and Distribution System or Wastewater CEUs. Registration must be submitted to FRWA if you wish to attend the training class. There is no charge for those not wishing to receive CEUs, however if you wish to receive CEUs there is an Administrative Fee of \$50.00 for FRWA members and \$80.00 for non-members, and \$90 for PDHs. If the administrative fee is paid less than five days prior to, or within ten days after the seminar, the fee will be \$100.00 for members and \$130.00 for non-members. FRWA must receive your written registration in order to reserve your seat. This class is subject to cancellation if registration is less than 10 attendees within 5 working days of the class.
