## CEU INFORMATION

This class provides 0.3 CEUs for drinking water, distribution system, and wastewater licenses and 3.0 PDHs. Registration must be submitted to FRWA if you wish to attend the training class. CEU forms will be handed out during class to those wishing to obtain CEUs. These forms are the only proof of attendance that will be recognized by FRWA as eligibility for CEUs to be awarded. Due to problems associated with CEU forms, all forms must be obtained, completed, and submitted at the end of each session to be accepted.

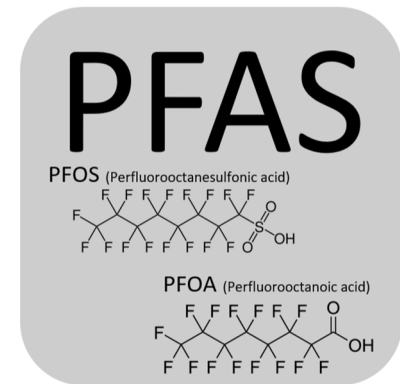
