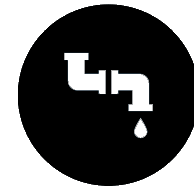

**Via I-4:** Take exit 27 for FL-570 E toward Lakeland/Winter Haven. From FL-570 E, take exit 10 for US-98 toward Lakeland/Bartow. Turn right onto US-98 S/Bartow Rd (signs for Polk State College). Turn left onto Ernest Smith Blvd. Turn left onto Old Bartow Eagle Lake Rd. Continue for 2.3 mi, Polk County Operations building will be on your right. Enter through gate.
