# Video Inspection Agreement

In consideration of the mutual covenants contained herein; it is agreed between the Florida Rural Water Association (FRWA) and \_\_\_\_\_ (System), as follows:

The Florida Rural Water Association makes this service available to member wastewater systems in an effort to reduce inflow and infiltration into their wastewater collection systems.

**For smoke testing, the Florida Rural Water Association (FRWA) will provide the following:**

1. Smoke testing equipment for use in inflow and infiltration studies.
2. Letter of recommendations for wastewater systems to use in notification of customers of pending smoke testing project.
3. A. FRWA field person to assist in manhole inspection program for systems with fewer than one thousand (1,000) connections.  
B. FRWA field person for one (1) day of training of wastewater systems personnel in what to look for in a manhole inspection program for systems over one thousand (1,000) connections.
4. A. FRWA field person to assist in smoke testing for wastewater systems under one thousand (1,000) connections.  
B. FRWA field person one (1) day of training of wastewater system personnel on proper smoke testing procedures for systems with over one thousand (1,000) connections.

**The member wastewater system will provide the following:**

1. No less than two (2) people familiar with the wastewater collection system to assist FRWA personnel in inspection of system.
2. Complete inspection of manholes and smoke testing at system and repair any problems encountered prior to the use of Camera Inspection Equipment.
3. System will be responsible for purchase of gas for the generator. System will also provide a cleaning area for Camera Inspection Equipment.
4. The System will provide blank VHS videotapes. If blank VHS tapes are not provided, the system will be charged \$5.00 per video provided by FRWA.
5. System will provide all necessary employees' insurance coverage and safety equipment for use by wastewater system personnel (not FRWA employees).
6. The system will provide necessary equipment, equipment operators, line locates and necessary employees to recover camera equipment if it gets stuck or hung up while inspecting system. FRWA does not have necessary equipment for use on equipment recovery.
7. This equipment is designed for use in sewer lines up to 15" in diameter only.
8. The system **must have** collection system lines cleaned to remove debris and roots **prior** to camera inspection since equipment cannot be used effectively in clogged collection systems.
9. The FRWA Wastewater Technician in charge of televising the sewer lines has the right to terminate the job at any time due to lack of/poor line cleaning, pipe debris, pipe blockage or any situation that prevents the equipment to operate as designed or poses a threat of becoming stuck.
10. The system agrees to pay the appropriate fees to FRWA for each day of equipment use. A fee of \$300.00 for each day the equipment is used is required to cover FRWA's cost of providing, repairing, and maintaining equipment for member system usage. Additional charges may include:

Charge	For
\$50.00	Each night an employee is required to stay overnight at your system.
\$.10	Per mile for towing the video trailer to your site
\$300.00	Each additional day that the camera is used at your site.

11. In addition, there will be a \$50.00 charge for per diem for employees if they are required to stay overnight to complete the video inspection. There may also be a charge of \$.10 per mile for towing the equipment to your site. If additional days are required, the total balance will be due to FRWA within thirty days of the final date of completion. Any accounts not paid in full at that time will be charged interest at a rate of 1.5% per month on all of the unpaid balance.
