

Welcome to the Common Intake Form, Atlanta's centralized portal for accessing multifamily housing developer incentives from the Atlanta Beltline, Inc., Atlanta Housing, City of Atlanta Department of Grants and Community Development, the Community Foundation of Greater Atlanta, the Funders Collective, and Invest Atlanta ("the Participating Agencies").

APPLY: The following centralized intake form is the first step to applying for financing with each of the participating partners. The form will ask for basic details regarding your development to establish eligibility.


REVIEW: After you have submitted the intake form, your application will be reviewed to ensure that it meets the necessary requirements for funding. If it does, you will be matched with the best-suited agency and funding source(s).

CONNECT: Once matched, you will receive an invitation to meet with the agency staff directly.

ADVANCE: Following this meeting, you will be invited to fill out the full application for funding.
