LICENSE HOLDERS!  
THE 2017 – 2018 (07/01/2017 thru 06/30/2018) COAM LICENSING  
APPLICATION PERIOD IS NOW OPEN!**

The COAM licensing application ([www.gacoam.com](http://www.gacoam.com)) is now open for the 2018 licensing period (07/01/2017 – 06/30/2018) to the following licensees:

- Master Class A – NEW and RENEWAL
- Master Class B – RENEWAL
- Location Class A – NEW and RENEWAL
- Location Class B – NEW and RENEWAL
- Manufacturers and Distributors – NEW and RENEWAL

Note: The Georgia Lottery Corporation is only accepting applications for NEW Class B Master licenses through an auction process for prequalified participants. Master license auctions occur at least once every three (3) years. The most recent auction took place on 05/03/2017 for prequalified participants.

Important Message to Corporate Partners, Licensing Officers, and Accounting Firms: As you prepare for this year's COAM license renewal and application period, be sure to take the time to review your business records and verify you have submitted COAM license applications for any new businesses that will be operating COAMs during the licensing year as well as not renewing for those businesses that are no longer operating COAMs or are no longer open.

## OTHER IMPORTANT DATES FOR COAM LICENSING

**05/31/2017**

Deadline to apply for a new location license (Class A and Class B), new Master Class A license, new Manufacturer or new Distributor license for the 2017 licensing period (07/01/2016 – 06/30/2017).

**06/30/2017**

Deadline for Master Licensees to purchase additional Class A and Class B decals or Location Licensees to add Class A and Class B machines for the 2017 licensing period (07/01/2016 – 06/30/2017).

**07/01/2017**

Date a \$1,000 late fee will be assessed to Location Class A and Class B licenses, Master Class A and Class B licenses, and Manufacturer and Distributor licenses that have not RENEWED for the 2018 licensing period (07/01/2017 – 06/30/2018). An existing COAM licensee will not be allowed to apply for a new license to avoid payment of late fee.

**09/30/2017**

Deadline to renew your Location Class A and Class B license, Master Class A and Class B license, and Manufacturer and Distributor license for the 2018 licensing period (07/01/2017 - 06/30/2018) with a \$1,000 late fee.
