Industry offers redemption information

With the July 1 date ushering in major redemption changes fast-approaching, Georgia's COAM industry is working to get the word

out about the new options. Come July, only gift cards (reloadable and non-reloadable), Lottery products and replays will be allowed for Class B redemption. The Georgia Amusement and Music Operators Association

(GAMOA) is partnering with the Horizon Retailers Association (HRA) and the Georgia Lottery Corp. to present an educational seminar April 28 about the coming gift card redemption options at the Cobb Convention Center (formerly

the Cobb Galleria), 2 Galleria Pkwy SE, Atlanta. The itinerary will feature a Lottery presentation by Mike Parham and other staff members.

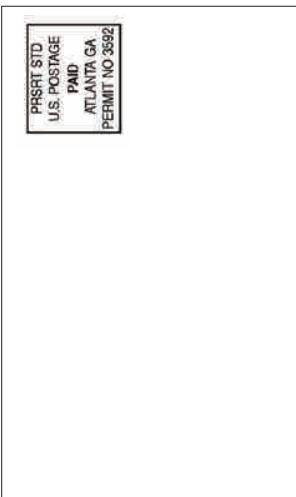
Amusement Hall of Fame welcomes Westgate

COAM licensing applications open May 4

The COAM licensing application process opens Monday, May 4, for the 2027 licensing period, which runs July 1, 2026, through June 30, 2027, on the Georgia Lottery Corp.'s COAM website, www.gacoam.com.

The licensing application process covers the following licenses:

- Master Class A – New and renewal
- Master Class B – Renewal only
- Location Class A – New and renewal

- Location Class B – New and renewal
 - Manufacturer – New and renewal
 - Distributor – New and renewal
- Licensees have the option to extend their license for one or

two additional years by submitting a multiple-year license application. To apply:

- First, submit your 2027 license application at www.gacoam.com.
- Then, visit the Documents/Forms section and download the multiple-year license application and follow the instructions on the application form.

Licensees who applied for a multiple-year license last year will receive an email before May 4 that provides instructions:

- to receive their license with updated license year term (all license types).
- to apply for their 2027 machine decals (Master License Holders only).

Licensees only applying for the 2027 license year do not need to submit a multiple-year license application.

The Lottery is not accepting any new Class B master license applications. New Class B master licenses are only available through an auction process for prequalified participants. The Lottery plans to hold a COAM auction for one Class B master license in April 2027. Additional details will be posted on the COAM licensing website as the date approaches.

The COAM Division has begun to email reminders to 2026 licensees to renew for the 2027 year.

Important dates:

The following are the important dates for licensees to remember:

- **Saturday, May 30:** Deadline to apply for a new location license (Class A and B), a new Class A master license, or a new manufacturer or distributor license for the 2026 licensing period (July 1, 2025, through June 30, 2026). This deadline only applies to 2026 COAM licenses.



- **Tuesday, June 30:** Deadline for master licensees to purchase additional Class A and Class B decals, or location licensees to add Class A and Class B machines for the 2026 licensing period (July 1, 2025, through June 30, 2026). This deadline only applies to 2026 COAM Licenses.

- **Wednesday, July 1 (IMPORTANT UPDATE):** Date a \$1,000 late fee will be assessed to location Class B licensees, master Class B licensees, manufacturer, and distributor licensees that have not renewed for the 2027 licensing period (July 1, 2026, through June 30, 2027). Additionally, a \$100 late fee will be assessed to location Class A licensees and master Class A licensees that have not renewed for the 2027 licensing period. An existing COAM licensee will not be allowed to apply for a new license to avoid payment of a late fee.
- **Monday, September 28:** Last

day to submit a renewal location Class A and Class B license, master Class A and Class B license and manufacturer and distributor license for the 2027 licensing period (July 1, 2026, through June 30, 2027). If a holder of a 2026 COAM license fails to renew its license, or its license application is not approved on or before this date, the person or entity will no longer be allowed to operate COAMs.

Master licensee's role



Master licensees can play an important role in helping their locations through the licensing process by reminding them to:

- pay their taxes and other state financial obligations.
- apply for the correct license (Class B).
- pay attention to licensing deadlines.
- list all the officers and shareholders listed on the license application.
- take time to enter information correctly.

on the redemption changes. A question-and-answer session with the Lottery regarding those changes will follow the presentation.

Another Q&A session with GAMOA attorney Les Schneider will follow for general COAM issues.

EasyLinx founder says

Representatives of several COAM businesses have talked with the Georgia Amusement Journal in the last few months about the coming gift card-focused redemption options.

The latest to do so is Mosart Sebben, founder and CEO of EasyLinx, who outlined several benefits the new redemption

requirements will provide.

“The new regulation creates a clear, auditable trail for every redemption, eliminating gray areas and protecting operators and locations from compliance risks while increasing trust with regulators,” Sebben said.

He also said the new redemption rules will allow operational standardization across all locations.

“Limiting payouts to replay tickets, gift cards, or lottery products simplifies processes, reduces staff errors, and creates a consistent redemption experience across every store and route,” he said.

“Higher revenue visibility” for owners and route operators will be another benefit, he said.

“With all redemptions tracked,” he said, “operators gain real insight into player behavior, machine performance, and payout ratios – unlocking smarter

decisions and new growth strategies.”

In addition, Sebben sees technology as a “growth enabler,” not a cost.

“The regulation accelerates adoption of RMS and validation systems, positioning system vendors as strategic partners that help routes and locations stay compliant, optimize revenue, and scale confidently.”

To his point, EasyLinx and GeWeTe have partnered with Betson to provide kiosks and software to take full advantage of the gift card redemption options.

Following is some general information regarding gift card redemption:

- Gift cards must be kept in secure areas (e.g., behind the counter) to prevent theft or tampering.
- Licensees are responsible for ensuring cards are not

accessible to unauthorized individuals.

- Gift cards must be redeemed for their full value. Licensees cannot charge a fee or withhold part of the value (e.g., giving a \$100 card but only redeeming \$80).
- Any suspicious activity involving gift cards (such as fraud or incorrect balances) should be reported to the Lottery immediately.
- The Georgia Lottery and COAM logos cannot be used on gift cards or player cards without explicit permission from the Lottery.
- Kiosks and similar technology aren’t required to provide gift cards.

The gift card redemption requirements were part of wide-ranging COAM legislation in House Bill 353 that passed in the 2024 General Assembly.

Reminder: Keep COAMs connected

To ensure accurate reporting of financial data to the Central Accounting System, the Georgia Lottery Corporation (GLC) says it is imperative the Location License Holders (LLHs) ensure all equipment remains connected to the site controller and powered up at all times.

The GLC maintains a record of those LLHs that are repeat offenders of failing to ensure the continuous connectivity and operation of Class B COAMs.

Failure to comply with these procedures may result in fines up to \$50,000, suspension and/or revocation of the license.

Decommission COAMs correctly

The proper procedure to decommission coin-operated amusement machines (COAMs) can be found on the COAM Division website, www.gacoam.com. The COAM decommission procedure should be followed when there is:

- A change of master, change of ownership, or cancellation letter received by GLC;
- A COAM game board swapped out with a different game;
- A COAM malfunction.

To proceed with the decommissioning:

1. Call Intralot before disconnecting the COAMs from a location and removing those COAMs. The Master License Holder (MLH) needs to contact the Intralot Hotline at 877-261-6242 to properly decommission COAMs. The COAMs must be connected to the site controller at this time.
2. Intralot will let you know when the COAMs are decommissioned. The Intralot representative will perform steps on the Intralot system that prepares the COAMs for the decommission. Once the steps are complete, Intralot will notify the MLH the machines have been decommissioned.
3. Disconnect decommissioned COAMs from the site controller.
