

2021 GBAA BOARD APPLICATION DIRECTOR AT LARGE

PROCESS

- 1. Application & Nominations: All new individuals wishing to be considered for a Board position should complete the Application and submit it to GBAA no later than September 25, 2021.
- 2. All applications will be reviewed by the Nominating Committee (NC). The Nominating committee consists of the 2020 GBAA Executive Board. (The NC can reject anyone who they feel does not meet the board qualifications)
- 3. The NC may conduct personal and/or phone interviews for all qualified applicants.
- 4. After a full review, the NC will present the slate of proposed board members to the GBAA Membership.
- 5. The slate of officers will be presented via email to all members of the Board of Directors at a virtual Membership Meeting in October.

All 2021 GBAA Board Members will be required to attend a New Board Member Orientation (date TBD). Depending on the COVID-19 Pandemic, the GBAA Board orientation may be held virtually.

EVALUATION

The Nominating Committee may consider the following when recommending a proposed slate of officers:

- Knowledge, experience and demonstrated commitment to GBAA through service to GBAA's Board of Directors and/or committees:
- Demonstrated leadership at the National, State and/or local level or relevant experience within your own company;
- Current multifamily housing industry experience, strong awareness of issues and relationships, and emerging trends affecting the industry;
- Skilled in multi-dimensional thinking and analysis;
- Possess strong interpersonal skills;
- A visionary open to new ideas, able to prioritize and consider future directions, have a clear view of the future:
- Objective in evaluating the ideas of others;
- Willing to invest in others as a mentor, able to inspire confidence and enthusiasm;
- Knowledgeable of (or the ability to learn) the fiduciary role of a governing body;
- Strong integrity to establish and maintain a personal code of conduct that serves as model for others:
- Support from employers/colleagues for the time and financial commitment required.
- Candidate's prior participation in AAA committees and/or their local affiliate.
- Candidate's recognized role in AAA, the industry and Civic/Social activities.

SELF APPRAISAL:

The applicant should consider the following to help them achieve a better understanding of their motivations for seeking office:

- Why do you want to serve as an officer of GBAA?
- Are you willing to sacrifice time, money and other goals?
- Can you identify with and work with the Executive Officers and Board Directors as a team member?
- Can you subordinate your personal biases to respond to the needs of the entire membership and organization?
- Can you relinquish authority and control when your term of service has ended?

All information discussed during meetings (board and otherwise) are highly confidential and cannot be discussed outside of the official meetings.

COMMITMENT:

Board Commitment & Travel

- 6 Board Meetings Annually. (Meetings are scheduled for the 3rd Thursday of the scheduled month from 3:30-5 PM in the GBAA Offices or online. Holidays and other outside events could alter these dates.
- Periodic travel as a representative of the association; and
- Possible miscellaneous meetings called by the Board throughout the year.
- Recruitment of new GBAA Members (Property Owners / Mgmt. Companies and Suppliers).
- Volunteer for events, assist with education and other board duties as needed.
- Offer knowledge and any information as it pertains to the Multifamily Industry to the Executive Director / Board of Directors.

TIME COMMITMENT:

In addition to the travel outlined above, participation will be required as follows:

- Regularly scheduled conference calls;
- Letter and report writing:
- Responding to mailings; and
- Reviewing minutes of meetings.
- Board of Directors Term(s) are from 1-3 Years (Board members cannot serve more than 4 consecutive years on the GBAA Board of Directors)
- The GBAA calendar year runs from January 1st through December 31, 2021.
