11:50 PM **CONVERSATION - A Call to Action**

Inequities for both women and underrepresented minorities in the corporate ladder begin early. Starting with manager-level promotions, the percentage of women and minorities advancing trails men and the inequities only increase with each step in the ladder. The pandemic also continues to take a toll on employees, but especially women, with stress levels escalating much faster among women than men as the work-life balance changes. Adding to these issues, the gender gap in pay has remained relatively stable in the United States for about 15 years. In 2021, women earned 83% of what men earned and the gap for Black and Latina women is far worse. What are companies doing to disrupt these inequities and support and help women and minority leaders to be successful? Diversity, Equity, and Inclusion (DEI) professionals will share the initiatives and tools their companies are deploying to drive results.
