Share with us what you are doing right now:

Sloan, TieDown Manufacturing, 50 year old company this year. We manufacture 7000 different parts, industries such as agriculture, manufactured housing, marine, contract manufacturing.

- Decreased business
- One COVID case, contracted at home
- We are back in the swing of things
- While loss of revenue, how do you offset that? You reach out to people who you have not talked with for a while.... It gives you an opportunity to expand your network. Found out what our customers need help with: PPE, hygiene... So we are now making portable wash stations! You only need a water supply like a garden hose, everything is touchless. Two types, inside use or outside.
- This one is for inside use, much more polished.
- On the industrial side, double sided, 6ft apart per sink. 240 people per hour. The most effective proven method is still soap/water vs hand sanitizers.

Jason: how about employee count?

- First laid off were temps, not full time employees. We had salary reductions and furloughs
- Yesterday we discussed plans to bring full time employees back.
- Yesterday we received our PPP loan, so we have more confidence to continue operations.

Jason: how are you bringing the new sanitizing stations to market, how can we help?

- Now through social media posts
- Re GMA support, we're looking for GA Manufacturers to support this product but need supply chain of consumables we have a two week ramp up, perhaps some of the members can help to shorten that. We never had to buy these products before, such as soap dispensers, etc.
- Would rather support GMA members first and then look for other GA suppliers





Justin Hughes, Dieselgrid: we are a freight transportation provider local to ATL, mostly in supply chain. Yesterday Justin learned that SBA will review and audit all PPP loans \$2 Million and over to make sure the right companies received the funds.

Jason Moss: Synovus said SBA will review them all. Necessity to get PPP loan for dire economic needs, no access to other funds. Seek legal and accounting input!

Joshua LeBarre, Sonnen: I am the director of manufacturing operations, oversee supply chain, the facility, inventory management. We make batteries for energy management products for residential use.

- Early January recognized the pandemic in China and knew it would hurt our supply chain so we made sure we had surplus supplies.
- March, alternate shifts, limited # of people on the floor, office work from home.
- Checks CDC daily for data.
- Google "GA public health" look for daily confirmed cases reported throughout the State of GA. If you look at the 7 day running average, that trend line is going down. However, it is not a clear whistle for Sonnen. Will keep working as is with split shifts etc.
- Customer service done from home, office support like supply chain people are now on rotational shifts

- Start looking at the new normal, and start planning for that now.
- We are building and shipping, we are looking for a good Q3 and Q4 as most orders are pushed to last two quarters.

LD deKatch, FastSigns Snellville:

- Filling different needs for companies to re-open, type of signage is adapting to the current needs.
- Making a lot of countertop shields right now
- Communication signs more than directional signs
- More graduation signage than ever before!
- Lobby is closed, drive up only.
- Frequency of GMA Zoom calls and connecting to other members outside of my geographic area is amazing, I love these calls! I have gotten to know people and their needs so much better through Zoom than ever before through live networking.

Comment Jason Moss - GMA plans going forward:

For May: all events virtual

For June: 1 tour, regular live events, 1 networking call only. Live networking to continue as

follows: June 2 is Alpharetta at 11:30am; June 5th Gwinnett at 8am & Cobb at 11:30.

For July: all live events and networking and very likely some virtual networking

Comment from participants:

Yedidah, Doosan: industrial vehicles, also sell forklifts and other material handling.

- Our dealers in North America cannot get hand sanitizer and we are able to support them. Also supply PPE for our essential office staff.
- Retail stores open, lobbies are closed. Lots of service calls, supplied on road techs with safety equipment. Have moved to servicing equipment in parking lots.
- We did not have any furloughs and layoffs of full time employees.
- Are having discussions on what to do when we go back. Some employees work better from home, more content and deepening their relationship with their dealer network and customers, it has been more beneficial for marketing.
- What will coming back to the office look like regarding signage, education, virtual learning.
- Our webinar next week has 300 people signed up.

JT Taylor, Adhesives and Equipment, has a business restart guidelines from our parent company. Employees in MI, IN, GA are slowly moving back inside. Outside employees, in sales, can only go if the customer lets us in. Q3 and Q4 strong outlook, especially automotive in the next 3-4 weeks.
