1. Breaking: HUD and CFPB scrutinizing the rental housing industry



On March 8, 2023, the U.S. Department of Housing and Urban Development (HUD) **released best practices** related to application fees and leasing costs. Secretary Fudge, via a letter, urged housing providers and companies that provide leasing services to adopt policies that promote fairness and transparency. The Biden Administration is seeking to eliminate "junk fees" and are calling for state crackdowns on "unavailable, unnecessary, or surprise charges." It also follows an extremely troubling and sweeping Request for Information issued jointly by the Federal Trade Commission and Consumer Financial Protection Bureau seeking information on source of income and resident screening practices. **IAA highly recommends that members view this document to understand the mindset of the Biden Administration and their potential future executive actions.**

It is clear that the Biden Administration is watching the industry extremely closely and intends to expand federal intervention into landlord/tenant matters via executive action. IAA will continue to provide updates, as they become available.

2. U.S. Senate Finance Committee holds Affordable Housing Hearing



On March 7, 2023, the Senate Finance Committee held a **hearing** on "Tax Policy's Role in Increasing Affordable Housing Supply for Working Families," during which the Low-Income Housing Tax Credit Program was a significant focus. Sharon Wilson Geno of the National Multifamily Housing Council was among those testifying on the importance of affordable housing tax credits and the need to expand and strengthen the program. Specifically, NMHC and other stakeholders pushed to restore the 12.5% allocation increase that sunset last year. Witnesses also addressed lowering the 50% bond financing threshold to 25%.

3. Biden's \$6.8T Budget seeks \$2T in tax hikes



On Thursday, March 9, President Biden introduced his \$6.9 trillion Fiscal Year 2024 budget for Congress' consideration, marking the beginning of a budget showdown with republicans, who control the House of Representatives.

• The proposal introduces a 25% minimum tax on billionaires, creates a new top income bracket at 39.6% for those making over \$400,000, and increases the corporate tax rate from 21% to 28%.

- The proposal is likely a non-starter for House Republicans.

4. HUD to change physical inspection criteria



HUD has been working for the past two years to evaluate and test new inspection criteria for HUD assisted and HUD insured Housing . NSPIRE- the National Standards for the Physical Inspection of Real Estate will replace the current REAC United Physical Condition Standards (UPCS) that are currently being used. The new standards become effective October 1, 2023, however, HUD has hinted that they may delay implantation. IAA will be hosting a **free webinar** on Tuesday, May 2 to assist members with the new standards, scoring methodology and new design requirement standards.
