### 1. HUD provides \$45M to PHAs to help Homelessness



On Monday, June 5, the U.S. Department of Housing and Urban Development (HUD) **awarded** Housing Choice Vouchers (HCV) to Continuum of Care (CoC) communities across the sate of Indiana. HCVs assist

households experiencing or at risk of homelessness, those fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, human trafficking, and veterans and families that include a veteran family member that meets one of the proceeding criteria.

### 2. Local: Floyd County to reissue 2023 Property Tax Bills




Property owners in Floyd County will be receiving an updated 2023 tax bill after an oversight that left \$89M out of the total assessment pool. According to the **News and Tribune's article**, Taxpayers, both commercial and residential, throughout the county, including in townships and New Albany, will garner credits if their spring bills have already been paid. The amount per taxpayer will vary, but many will see deductions in what's owed for 2023.

#### **Background:**

In August 2022, the auditor's office failed to submit to the state a form including taxing values for railroad and utility properties in Floyd County. As a result, about \$89 million was left off the assessments. The taxing values had to be adjusted to meet the rate, therefore residential and commercial property owners saw their 2022 assessed rates due in 2023 raised to account for the \$89 million that was left off the rolls.

### 3. Reminder: Property Tax Appeals Due June 15



On average, Hoosier property owners of all types (commercial, industrial, and residential) saw average property tax assessments increase by over 14%. Property owners who disagree with their assessment need to file an appeal by Thursday, June 15.
