Minutes from both meetings are attached. The President reported that Florence, Italy was the clear winner of the two bidders for 2026 and that a confirmatory site visit will be organized.

8. Renewal of the Contract with Holland-Parlette (2021-2024), Christine Roland-Lévy

The President spoke to the recommendation of the Executive Committee that a new contract be negotiated with the management company Holland-Parlette for the continued management of the association (Appendix 12).

Janel Gauthier / Luminita Patras **MOVED** to approve the negotiation of a new contract with Holland-Parlette. **Motion adopted.**

9.1 Elections Committee, Janel Gauthier

The Chair of the Elections Committee spoke briefly to his written report (Appendix 13) and the results of the elections in 2020.

9.2 Committee on Awards, Janel Gauthier

The Chair of the Committee on Awards spoke briefly to his written report (Appendix 14).

9.2.1 Rules of procedure for IAAP Awards – Approval

Janel Gauthier spoke about the need for the Committee on Awards to have all the information about how to proceed for the IAAP awards inserted in a single document and that the document be approved by the Board of Directors for its use by the Committee. Then, on behalf of the Committee, he presented a motion asking the BoD to approve a document called "Procedures for the Awards of the International Association of Applied Psychology" (Appendix 15) with the addition of two paragraphs: one to provide information about the period of nomination for the Awards; and the other to clarify the steps to be completed before announcing who are the recipients of the IAAP awards.

Janel Gauthier, on behalf of the Committee on Awards, **MOVED** that the BoD approve the *Procedures for the Awards of the International Association of Applied Psychology* as submitted and amended.

Motion adopted.

9.3 Committee on Fellows, Janel Gauthier

The Chair of the Committee on Fellows spoke briefly to his written report (Appendix 16).

9.3.1 Rules of procedure for election of Fellows: Approval

Janel Gauthier spoke about the need for the Committee on Fellows to have all the

information about how to proceed for the nomination and the election of IAAP Fellows inserted in a single document and that the document be approved by the Board of Directors for its use by the Committee. Then, on behalf of the Committee, he presented a motion asking the Board to approve a document called "Procedures for Nomination and Election of IAAP Fellows" (Appendix 17) with the addition of a paragraph aiming to reflect a Board approved amendment to the definition of Fellow in the *Constitution* and the addition of a section designed to provide information about the range of contributions considered in the evaluation of nominations for Fellows (Appendix 17).

Janel Gauthier, on behalf of the Committee on Fellows, **MOVED** to that the BoD approve the document *Procedures for Nomination and Election of IAAP Fellows* as submitted and amended.

Motion adopted.

9.4 Committee on Constitution & Rules of Procedure, Janel Gauthier

The Chair of the Committee on Constitution & Rules of Procedure spoke briefly to his written report (Appendix 18).

9.4.1 IAAP Constitution: Proposed Amendments

9.4.1.1 Term of IAAP President-Elect

Janel Gauthier presented two motions.

First, he presented a motion to change the term of office for President-Elect from 2 years to 4 years (Appendix 19).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the duration of the term of office for the President-Elect of the Association be changed from 2 to 4 years as recommended by the Committee on the Constitution and the Rules of Procedure and the Executive Committee.

Motion adopted.

Second, he presented a motion to approve a proposed amendment to Section 8.03 of the *Constitution* to reflect the change in the duration of the term of office for the President-Elect of the Association from 2 years to 4 years (Appendix 19).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the BoD approve the amendment to Section 8.03 of the *Constitution* as proposed.

Motion adopted.

9.4.1.2 Term of Division Presidents-Elect

Janel Gauthier presented two motions.

First, he presented a motion to change the term of Division President-Elects from 2 years to 4 years (Appendix 20).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the duration of the term of office for Division Presidents-Elect be changed from 2 to 4 years as recommended by the Committee on the Constitution and the Rules of Procedure and the Executive Committee.

Motion adopted.

Second, he presented a motion to approve a proposed amendment to Section 7.03 of the *Constitution* to reflect the change in the duration of the term of

office for the Division Presidents-Elect of the Association from 2 years to 4 years (Appendix 20).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the BoD approve the amendment to Section 7.03 of the *Constitution* as proposed.

Motion adopted.

9.4.1.3 Article 7: Board of Directors (Section 7.02)

Janel Gauthier presented a motion to approve a proposed amendment to Section 7.02 in Article 7 of the *Constitution* to clarify the status and the voting rights of the past presidents of IAAP on the Board of Directors and whether the number of past presidents is to be considered to determine the quorum required for meetings (Appendix 21).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the BoD approve the amendment to Section 7.02 in Article 7 of the *Constitution* as proposed.

Motion adopted.

9.4.1.4 Article 9: Elections (Section 9.01)

Janel Gauthier presented a motion to approve a proposed amendment to Section 9.01 of the *Constitution* to harmonize it with an amendment to the *Rules of Procedure* approved by the BoD in 2014 (Appendix 22).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the Board of Directors approve the following amendments to Section 9.01 of the *Constitution*:

- Deletion of the following sentence at the beginning of Section 9.01: 'The Board of Directors shall select a list of candidates for President-Elect to be submitted to the IAAP general membership (dues paid Full members and Fellows) for a vote.'
- Insertion of the following sentence at the beginning of Section 9.01: 'Full Members and Fellows in good standing with IAAP (i.e., membership dues paid) shall elect the President-Elect according to rules of procedure determined by the Board of Directors.'

Motion adopted.

9.4.1.5 Article 11: Meetings (Section 11.01)

Janel Gauthier presented a motion to approve a proposed amendment to Section 11.01 of the Constitution to define a meeting quorum (Appendix 23).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that Section 11.01 of the *Constitution* be amended to indicate that "A quorum shall be more than half of the voting members of the Board of Directors."

Motion adopted.

9.4.1.6 Article 13: Life of the Association (Section 13.01)

Janel Gauthier presented a motion to approve a proposed amendment to Section 13.02 of the *Constitution* requiring a two-thirds vote of the Board of Directors in a meeting attended by more than half of the Board of Directors to terminate the Association. (Appendix 24).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** to approve the amendment to Section 13.02 of the *Constitution* as proposed.

Motion adopted.

9.4.1.7 Article 14: Amendments (Section 14.01)

Janel Gauthier presented a motion to approve a proposed amendment to Section 14.01 to indicate that amendments to the *Constitution* approved by the Board of Directors take effect immediately upon their approval unless the Board of Directors decides otherwise. (Appendix 25).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** to approve the amendment to Section 14.01 of the *Constitution* as proposed.

Motion adopted.

9.4.1.8 Ratification of Constitution as amended

Janel Gauthier presented a motion to ratify the *Constitution* as amended in June 2018 and December 2020 (Appendix 26).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the Board of Directors ratify the *Constitution* as amended in June 2018 and December 2020.

Motion adopted.

9.4.1.9 Designation of body acting as General Assembly

Janel Gauthier presented a draft proposal to designate a General Assembly (Appendix 27) and the BoD discussed the merits of the proposal. An unofficial poll ("straw vote") was taken to gauge support for the draft proposal: 25 voted "In Favour", 3 voted "Against", and 6 abstained from voting. It was agreed that work on the proposal would be pursued and that a final proposal would be submitted to the BoD for review, at the next BoD meeting in 2022.

9.4.2 IAAP Rules of Procedure

9.4.2.1 Proposed amendments to Section 1.2.1

Janel Gauthier presented two motions.

First, he presented a motion to approve a proposed amendment to Section 1.2.1 of the *Rules of Procedure* to indicate that President-Elect candidates may insert a link to a web page in their resume/statement to provide voting members with additional information about their nomination (Appendix 28).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** to approve the amendment to Section 1.2.1 of the *Rules of Procedure* as proposed.

Motion adopted.

Second, he presented a motion to approve a proposed amendment to Section 1.2.2. of the *Rules of Procedure* to request that candidates for President-Elect provide an e-mail address that can be used by voting members to contact them

to ask questions about their resume or statement during the election period. (Appendix 28).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** to approve the amendment to Section 1.2.2. of the *Rules of Procedure* as proposed.

Motion adopted.

9.4.2.2 Ratification of Rules Procedure as amended

Janel Gauthier presented a motion to ratify the *Rules of Procedure* as amended in July 2016 and December 2020 (Appendix 29).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** that the BoD ratify the *Rules of Procedure* as amended in July 2016 and December 2020.

Motion adopted.

9.4.3 Rules of Procedure for Election of Division Presidents-Elect

9.4.3.1 Proposed amendment to Rule #8

Janel Gauthier presented a motion to approve a proposed amendment to Rule #8 in the *Rules of Procedure for the Election of IAAP Division Presidents-Elect and Other Officers* to harmonize it with Section 7.03 of the *Constitution* which was amended earlier to change the duration of the term of office for the Division Presidents-Elect of the Association from two years to four years (Appendix 30).

Janel Gauthier (on behalf of the Committee on the Constitution and the Rules of Procedure) / Christine Roland-Lévy (on behalf of the EC) **MOVED** to approve the amendment to Rule #8 in the *Rules of Procedure for the Election of IAAP Division Presidents-Elect and Other Officers* as proposed.

Motion adopted.

9.4.3.2 Ratification of Rules of Procedure for Election of Division Presidents-Elect Janel Gauthier presented a motion to ratify the *Rules of Procedure for the*

Election of IAAP Division Presidents-Elect and Other Officers adopted July 2016 as amended in December 2020 (Appendix 31).

Robyn Vines suggested more strategic links with national organizations and heads of schools of psychology.
