3:45 PM	4:45 PM	Mental Health is Not Simply the Absence of Mental Illness: Implications for Workers' Compensation Systems
		Mental health is top of mind for workers, workplaces, and workers' compensation systems. However, most of the discussion about mental health focuses on the absence of mental illness. Many workers who do not have a mental illness are nonetheless experiencing poor mental health, which can affect performance, productivity,

and return-to-work. During this session, Dr. Kathleen Dobson and Dr. Michael Lacroix will describe the nuance between mental illness and mental health, discuss Dr. Dobson's recent findings regarding how these different constructs are associated with wage replacement claim durations in the Ontario workers' compensation system, and then lead a discussion on the implications for workers' compensation regulators.
