Financial Report

The IAIABC has performed in-line with budget through the third quarter of 2019. The Association has experienced revenue gains in some areas, including EDI training, jurisdictional membership, and investments which have offset shortfalls in education and associate membership. Face-to-face events

have had a strong financial performance for the year. Currently, the Association is projected to achieve budget through the year.

The Audit Committee is completing a review of the IAIABC Investment advisor and will be making recommendations on any changes to the investment strategy to the Board of Directors.

Membership Report

We have welcomed 20 new members this year. The IAIABC's retention rate of 92.5% is higher than the average for trade associations, and we continue to have high member satisfaction. Dues invoices for 2020 went out 2 weeks ago.

EDI XML Update

The IAIABC plans to release its own XML standard in the spring of 2020. An RFP is out now for a partner to work on the project, and we will have a more firm timeline once we start working with an XML project partner.

Strategic Plan Update

The current Strategic Plan was approved at the end of 2017 and goes through 2020. Progress updates and upcoming tasks and strategies were discussed during the Board of Directors meeting on Sunday.
