

CLICK WRAP AGREEMENT  
FOR THE PUBLIC AND IAIABC MEMBERS OF  
THE IAIABC STANDARDS TRADING PARTNER TABLES AND STANDARDS  
IMPLEMENTATION GUIDES  
FOR INTERNAL, NON-COMMERCIAL USE ONLY

1. The Claims, Medical, and Proof of Coverage Standards Implementation Guides (“Guide”), explain how to use the associated Trading Partner Tables. The Implementation Guides includes the Data Dictionary. Both the Guides and the Trading Partner Tables are copyrighted by IAIABC and all rights which are not authorized below are reserved to IAIABC.

2. The Guide

a. If you are a state agency, you and your employees are authorized to use the Guide only as needed to develop electronic reporting guidelines internally within your agency for the sole purpose of administering your state Workers Compensation laws.

b. If you are an individual or corporation other than state agency, you and your employees may only use the Guide internally within your organization for the sole purpose of complying with reporting requirements mandated by state Workers Compensation laws or administrative rules.

c.
