Since receiving the award, so many doors have opened for me in the IAIABC community and Workers' Compensation Industry as I have had the opportunity to present at conferences, participate in the Accidentally Podcast, join IAIABC Committees and connect with fellow NextGen winners on a consistent basis.

## Who can be nominated for an IAIABC NextGen Award?

Nominees must be under the age of 40 as of December 31, 2024. Nominees do not need to work for an IAIABC member organization but must work in the workers' compensation industry. Nominees cannot have previously won an IAIABC NextGen Award. Nominees should set themselves apart from others through their substantial, positive impact on their organizations and/or the workers' compensation industry.

## How are the IAIABC NextGen Award Winners selected?

Each year, nominations are open to the workers' compensation industry to nominate individuals for an IAIABC NextGen Award. A committee of industry professionals reviews the nominations and selects each year's winners. This is a competitive award, and nominators are asked to provide as much detail as possible to help the committee make informed decisions.

## What is the nominating process like?

Nominees cannot self-nominate, so it is incumbent upon peers and colleagues to nominate individuals they feel are worthy! Nominees will go through a preliminary review, after which finalists will be selected. Finalist nominators will be asked to submit a statement of support from a third-party individual (one who is not the initial nominator or the nominee). Winners will be selected from the pool of finalists.

## What are the important NextGen Award dates?

Nominations will open on February 20, 2024, and must be received by March 20. Finalist statements of support will be requested beginning April 16 and close on May 3. Winners will be notified and announced by May 28.

## How are the winners recognized?

Winners will receive a complimentary registration to the IAIABC 110th Convention, September 23-26, 2024, and be asked to participate in a NextGen session during the Convention. Winners will be featured in a special edition of IAIABC Perspectives Magazine and on the IAIABC's website and in social media and press campaigns.
