


Membership renewal is now open to all IASPA members and you can go ahead and log into your profile and Renew at your earliest convenience.

Verifent

Per Faith's Law (P.A. 102-702), public and non-public Illinois school districts are required to conduct an Employment History Review for all employees, contractors, substitutes, and all those with direct contact with students who are hired on or after July 1, 2023.

### Verifent provides an electronic Employment History Review process that is easier, more efficient, and more cost-effective than a paper process.

<u>Verifent</u> is an industry leader in the Employment Income Verification (EIV) process. As mortgage lenders pay the fee for this service, there is no cost to school districts! To assist school districts across the country, Verifent has added an Experience Verification (EV) product (including a misconduct component) in other states.

Most recently, Verifent is completing an Employment History Review

component (per Faith's Law) for Illinois. This component is on track to be finalized on or before June 1, 2023.


