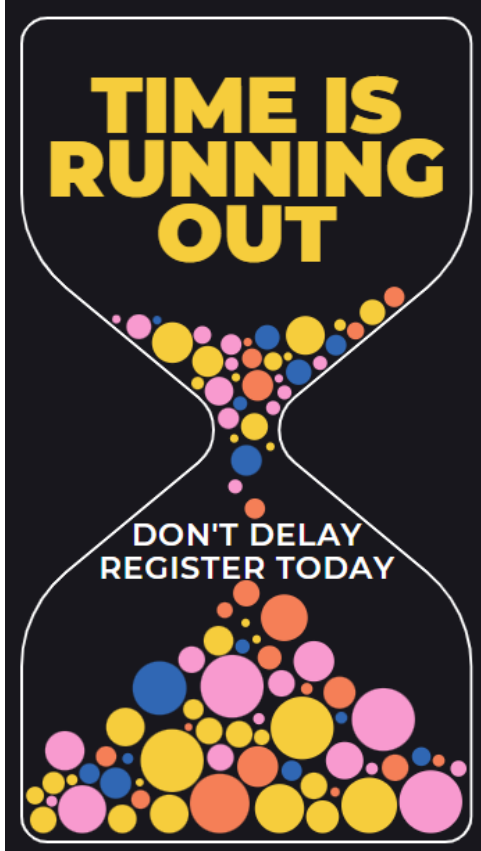

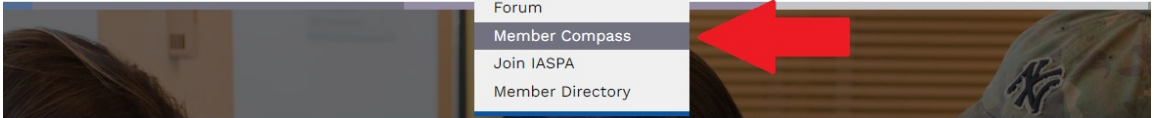
Membership renewal is now open to all IASPA members and you can go ahead and log into your profile and Renew at your earliest convenience.

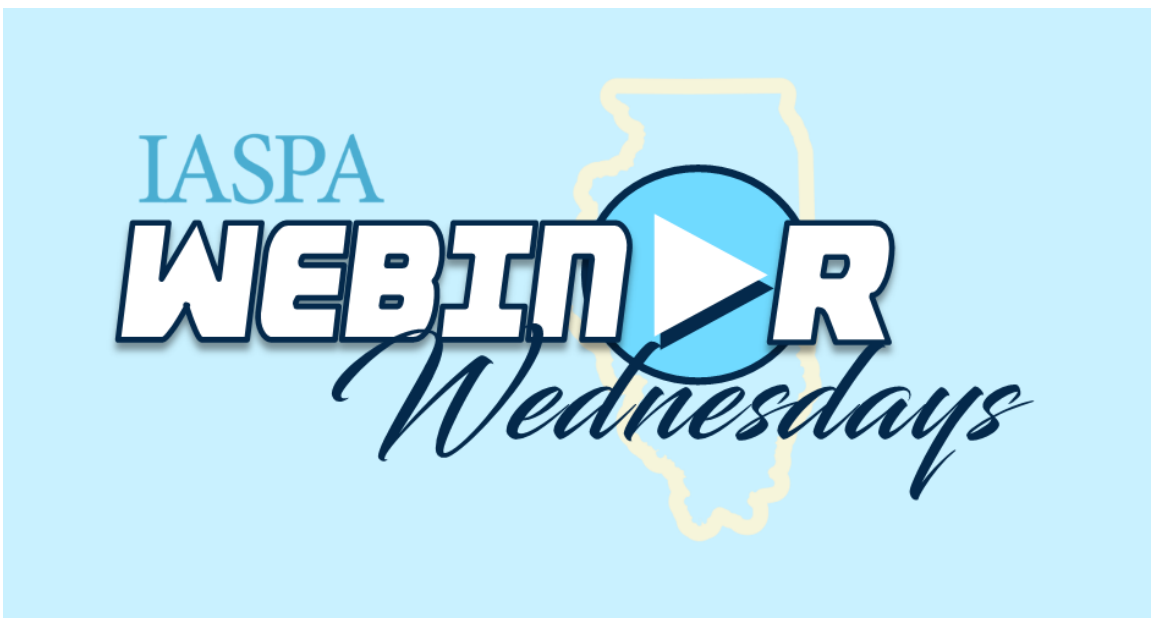
