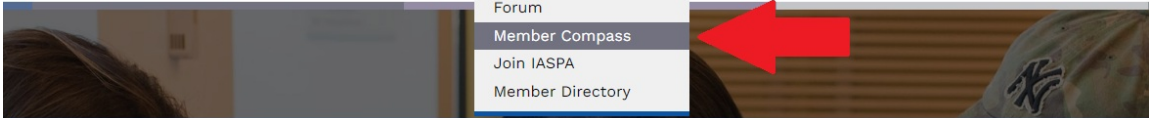
Membership renewal is now open to all IASPA members and you can go ahead and log into your profile and Renew at your earliest convenience.

Per Faith's Law (P.A. 102-702), public and non-public Illinois school districts are required to conduct an Employment History Review for all employees, contractors, substitutes, and all those with direct contact with students who are hired on or after July 1, 2023.

Most recently, Verifent is completing an Employment History Review component (per Faith's Law) for Illinois. This component is on track to be finalized on or before June 1, 2023.
